The Town of Phelps Schedule of Regulations, identified in §145-8 of the Town of Phelps Zoning Ordinance and attached to the Town of Phelps Zoning Ordinance, is hereby amended with the insertion of a new Special Permitted Use in the R-AG Agricultural-Residential District to read as follows:

Planned development groups, in accordance with § 145-18, excluding properties located within Ontario County Consolidated Agricultural District 1

Section 2. The Town of Phelps Schedule of Regulations, identified in §145-8 of the Town of Phelps Zoning Ordinance and attached to the Town of Phelps Zoning Ordinance, is hereby amended with the insertion of a new Special Permitted Use in i) the C-1 Commercial District and ii) the M-1 Industrial District to read as follows:

Planned development groups, in accordance with § 145-18

- **Section 3.** Paragraph D of § 145-8.1 (Neighborhood Commercial District) of the Town of Phelps Zoning Ordinance is hereby amended with the insertion of a new specially permitted use in a new subsection (6) to read as follows:
 - (6) Planned development groups, in accordance with § 145-18

Section 4. If any clause, sentence, paragraph, section or part of this local law shall be adjudged by any court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, section or part thereof directly involved in the controversy in which such judgment shall have been ordered.
