

ORDINANCE 2023-03-806

AN ORDINANCE TO AMEND AN ORDINANCE ENTITLED “AN ORDINANCE OF THE BOROUGH OF PINE BEACH IN THE COUNTY OF OCEAN, ESTABLISHING MINIMUM-MAXIMUM LIMITATIONS ON SALARIES TO BE PAID THE MAYOR, COUNCILPERSONS, AND ALL OTHER MUNICIPAL OFFICERS AND EMPLOYEES OF THE BOROUGH”, AND REPEALING ALL PRIOR ORDINANCES.

BE IT RESOLVED by the Mayor and Council of the Borough of Pine Beach, in the County of Ocean, and State of New Jersey, as follows:

SECTION 1: The annual salaries to be paid by the Borough of Pine Beach to the Mayor, Councilpersons, and the municipal officers and employees of the Borough shall not be less than the minimum or more than the maximum sums set forth in Section 2 hereof.

SECTION 2: The minimum and maximum salaries of the Mayor, Councilpersons, and those municipal officers and employees herein enumerated shall be as follows:

SECTION 3: The Borough Council shall from time to time determine by resolution the exact salary to be paid the Mayor, Councilpersons, and other enumerated officers and employees within the limitations set forth in Section 2 hereof and establish the effective date thereof which effective date shall not be less than twenty days later than the date of passage of said resolution. Said resolution may provide that all said salaries may be retroactive to January 1, unless otherwise stated in the year that said resolution shall be adopted.

SECTION 4: The minimum and maximum salary limitations established in Section 2 hereof and any resolution of the Borough Council fixing the exact salary of the Mayor, Councilpersons, or enumerated officers and employees, shall be subject to the referendum provisions of Title 40A:, Chapter 9, Article 168 of the Revised Statutes of the State of New Jersey.

SECTION 5: All prior Ordinances of the Borough of Pine Beach establishing salaries and salary ranges are hereby repealed, except that salaries being paid the Mayor, Councilpersons, or other officer and employees pursuant to prior Ordinances shall continue to be paid in the like manner and amount until the effective date of any modification thereof made pursuant to Section 3 of this Ordinance.

SECTION 6: This Ordinance shall take effect twenty days after its final passage, approval and publication as provided by the law subject to the provisions of Title 40A: Chapter 9, Article 168.
