## ORDINANCE NO. 11, 2023

AN ORDINANCE OF THE MAYOR AND COUNCIL OF THE BOROUGH OF PITMAN, COUNTY OF GLOUCESTER, STATE OF NEW JERSEY, REPEALING CHAPTER 3, POLICE REGULATIONS, SECTION 3-18.1, RECREATIONAL VEHICLES, COMMERCIAL VEHICLES, BOATS, CERTAIN COMMERCIAL/INDUSTRIAL VEHICLES, AND AMENDING CHAPTER 7, VEHICLES AND TRAFFIC OF THE CODE OF THE BOROUGH OF PITMAN

WHEREAS, the Mayor and Council of the Borough of Pitman have determined the necessity of certain amendments to Chapter 3, Police Regulations, specifically as it relates to Section 3-18.1, Recreational Vehicles, Commercial Vehicles, Boats, Certain Commercial/Industrial Vehicles, Equipment and Trailer; Unregistered Vehicles and Chapter 7, Vehicles and Traffic; and

WHEREAS, pursuant to N.J.S.A. 40:48-2, the governing body of a municipality may make, amend, repeal, and enforce such other ordinances, regulations, rules and by-laws not contrary to the laws of this state or of the United States, as it may deem necessary and proper for the good government, order and protection of person and property, and for the preservation of the public health, safety and welfare of the municipality and its inhabitants, and as may be necessary to carry into effect the powers and duties conferred and imposed by this subtitle, or by any law; and

WHEREAS, the Mayor and Council of the Borough of Pitman deem it in the public interest to repeal Ordinance No. 24-2011 as it appears in Chapter 3, Police Regulations; and

WHEREAS, the Mayor and Council of the Borough of Pitman deems it appropriate to amend Chapter 7, Vehicles and Traffic, specifically section 7-15, of the Borough Code to include Ordinance 24-2011, as previously published, as the Ordinance should have originally been included within that Chapter;

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Council of the Borough

of Pitman, in the County of Gloucester and State of New Jersey, and it is hereby enacted and ordained by the authority of same as follows:

<u>Section 1.</u> Ordinance No. 24-2011 is hereby repealed from Chapter 3 of the Borough Municipal Code.

<u>Section 2.</u> Chapter 7, Vehicles and Traffic shall be amended to include Ordinance No. 24-2011, in its entirety as previously published, within Chapter 7, Section 15, Parking Prohibited During Certain Hours on Certain Streets, as **section (i)**:

i. It shall be unlawful in any residential zone for any person to permit or to have parked or stored on any public street or right-of-way any unregistered motor vehicles, recreational vehicles, commercial vehicles, motor homes, travel trailers, campers, boats, trailers, jet skis, snowmobiles, or other such construction, contractor, tractor-trailer unit, either singly or in combination, school buses, commercial landscaping, industrial equipment and material such as, but not limited to, bulldozers, graders, dump trucks, rollers, tree and stump chippers and grinders, lawn mowers, fertilizer spreaders, tillers, construction and other building materials and equipment.

<u>Section 3</u>. All sections of the Borough Code not amended hereunder shall remain in full force and effect.

<u>Section 4.</u> Severability. In the event any section, part or provision of this Ordinance shall be held unconstitutional or invalid by any Court, such holding shall not affect the validity of this Ordinance or any remaining part of this Ordinance other than the part held unconstitutional or invalid.

<u>Section 5.</u> Repealer All ordinances or parts thereof which are inconsistent with the provisions of this Ordinance are hereby repealed to the extent of their inconsistencies.

<u>Section 6.</u> *BE IT FURTHER ORDAINED* this Ordinance shall take effect immediately upon its final passage and publication as required by law.
