Safety: Fuel Management

No one intends to run out of fuel, and most pilots who have dipped into their fuel reserves vow never to do it again. But through a combination of circumstances and poor decisions, pilots still crash short—often in sight of their destination.

Think of available fuel in hours and minutes instead of gallons and pounds. While range will vary constantly due to changing winds and ground speeds, endurance is based on how much fuel the engine burns at a given combination of altitude, power setting, and mixture setting. Your pilot's operating handbook (POH) will provide guidance to determine hourly fuel consumption.

Know the fuel system of the airplane you fly. Some systems are quite simple, while others may be complex and include auxiliary and aftermarket tip tanks with electric boost and fuel transfer pumps. Pilots have made forced landings with fuel still available because they did not understand the system or operate it properly.

Fuel pump configuration and use varies from one model to another, and sometimes within a model.

High wing—In most carbureted high-wing designs, gravity feeds fuel from the tank to the engine. Most higher power and high-altitude, highwing designs also have an auxiliary fuel pump.

Low wing—If the fuel supply is lower than the engine, fuel must be pumped, and most low-wing designs have at least two fuel pumps. The main pump is usually mounted on the engine and driven mechanically. The auxiliary electric fuel pump in some designs must be on for landing and takeoff; in other designs it may be used for priming, high-altitude flight, or as an emergency backup should the mechanical pump fail.

Avoid Misfueling

The consequences of introducing an improper fuel into an aircraft's tanks range from the benign (fuel system drainage) to the expensive (engine replacement) to the disastrous (engine failure shortly after takeoff). Given simple precautions, all are easily preventable, starting with pilot oversight during the fueling process.

Many pilots think that sumping the tanks will reveal a fueling error. However, that may not always be true. The blending of two different fuels within the tank can mask the color and smell distinctions that would normally signify a problem. Also mistaken is the assumption that a misfueled engine will fail to start, or will run poorly. In many cases, the engine may seem to run normally for quite some time—long enough to lure a pilot into a false sense of well-being



Safety contd.

Fueling. Be present every time your aircraft is fueled: State fuel grade, quantity, and tanks to be filled.

Know what's in your tanks—check for water or contaminants and verify they are filled with the proper fuel grade.

Secure fuel caps after you check the tank.

Determine available fuel in hours and minutes instead of gallons and pounds.

Lean the mixture to achieve the best performance, range, and endurance.

Recalculate range and endurance hourly to maintain adequate fuel reserves.

Land with at least one hour of fuel.

Know the fuel system—understand how and when to use boost pumps, auxiliary tanks, and fuel transfer pumps.

Use a timer to remind you to switch tanks during flight.

Switch tanks before reaching pattern altitude. Land as soon as possible if you're low on fuel.

Declare a fuel emergency with ATC to get priority handling.

Answers

- **4. The correct answer is A.** NASA studies determined that typical altitude loss in spins was nearly 1,200 feet. Remember this while in the traffic pattern, generally flown at 1,000 AGL. Think ahead about where to land in an emergency, and remember to keep your turn from base to final coordinated and go-around if you cannot line up on final. Overbanking or applying too much rudder in the turn from base to final, at a slow airspeed and a high angle of attack, could result in a stall/spin.
- 3. The correct answer is C. When a secondary stall occurs, the pilot should perform the exact same stall recovery procedures as he or she would do in a power-off stall. The first action should be to reduce the angle of attack by applying nose-down elevator pressure to eliminate the stall warning. Then, level the wings with ailerons, coordinate with rudder, and adjust power as needed. When the airplane is no longer in a stalled condition the pilot can return the airplane to the desired flightpath.
- **2.** The correct answer is **A.** Weight is a key factor that affects an aircraft's stall characteristics. Others include CG location, turbulence, and wing contamination
- 1. The correct answer is A. The airflow produced by an aircraft moving through the air is known as the relative wind, which is always directly opposite the movement of the aircraft. The angle between the relative wind and the chord line of the wing is known as the angle of attack (AOA). The critical angle of attack is where the aircraft stalls. Although the pitch required to achieve this angle of attack changes with varying load factors, an airplane will always stall when the critical angle of attack has been exceeded.
