AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF PITTSTON, LUZERNE COUNTY, PENNSYLVANIA, AMENDING SECTIONS OF THE CITY OF PITTSTON (ORDINANCE NO. 3 OF 2006) RESIDENTIAL PERMIT PARKING

BE IT ENACTED AND ORDAINED BY THE CITY OF PITTSTON and it is hereby enacted and ordained by authority of the same as follows:

- 1. Repeal §455-39 of the Pittston City Code in its entirety
- 2. Amend §455-40 to add as follows:

Area

East Street
High Street
Elizabeth Street
Johnson Street

Bounded By and Not Including

Kennedy Boulevard and Johnson Street
East Street and W Columbus Ave
East Street and W Columbus Ave
East Street and W Columbus Ave

- 3. Amend §455-41 to replace "Chief of Police" with "Treasurer's/Tax Collector's Office". And to add: Each individual resident who resides in the "AREA" shall be entitled to one free permit. Additional permits for qualifying individuals/owners shall be able to obtain one additional permit for \$25 annually.
 - 4. Amend §455-42 from:

Upon receipt of the application and determination by him that the information upon the application shows that the applicant is entitled to a residential parking permit, the Chief of Police shall issue to the applicant a residential parking permit, which shall be valid for the remainder of the calendar year. The permit shall display the serial and registration numbers of the motor vehicle, the residential parking area number, and the expiration date. The permit shall be renewable annually before the expiration date, upon making application for renewal. It shall be unlawful and a violation of this article for any person to display other than the current and valid permit while standing or parking in a residential permit parking area at the time when those permits are to be displayed.

Upon receipt of the application and determination that the information upon the application shows that the applicant is entitled to a residential parking permit, the Treasurer's/Tax Collector's Office shall issue to the applicant a residential parking permit, which shall be valid for the remainder of the calendar year. The permit shall be renewable annually upon making application for renewal. It shall be unlawful and a violation of this article for any person to display other than the current and valid permit while standing or parking in a residential permit parking area at the time when those permits are to be displayed.

- 5. Amend §455-43 to replace "Chief of Police" with "Treasurer's/Tax Collector's Office".
- 6. Amend §455-45 to replace "Chief of Police" with "Treasurer's/Tax Collector's Office".

Effective Date and Codification. This Ordinance shall take effect immediately upon adoption. The City Administrator shall transmit a true and original copy to the City codification contractor for inclusion in the Pittston City Code.
