ORDINANCE NO. 23-20

AN ORDINANCE AMENDING THE MUNICIPAL CODE OF THE CITY OF PIERCE CITY, MISSOURI, BY ALLOWING ONE MEMBER OF THE ADVISORY PARK BOARD TO LIVE OUTSIDE THE CITY LIMITS OF PIERCE CITY AND DELETING REFERENCES TO VOTING

WHEREAS, the City has an advisory park board pursuant to Section 140.010 for the betterment of the City and Welfare of the citizens, and the City benefits from and serves benefit to citizens outside the city limits, and

WHEREAS, the Park Board pursuant to Section 140.010 is advisory in nature and does not make decisions, but instead brings forth ideas for the betterment of the community, and

WHEREAS, the citizens and City would further benefit by amending the Municipal Code of the City of Pierce City, Missouri, Section 140.020 by adding: "advisory" and "six (6) members. One member shall be a member of the Board of Alderman and at least Four (4) members shall reside inside the city limits" and deleting "voting" and "non-voting."


BE IT ORDAINED BY THE COUNCIL OF THE CITY OF PIERCE CITY, MISSOURI, AS FOLLOWS:

The Advisory Park Board shall consist of six (6) members. One member shall be a member of the Board of Alderman and at least Four (4) members shall reside inside the city limits of the City of Pierce City.


This Ordinance is found to be in the best interest of the citizens of Pierce City.
