ORDINANCE NO. 1702

PLYMOUTH TOWNSHIP  
MONTGOMERY PENNSYLVANIA

AN ORDINANCE AMENDING THE CODE OF PLYMOUTH TOWNSHIP,  
MONTGOMERY COUNTY, PENNSYLVANIA, AT CHAPTER 2  
“ADMINISTRATION,” AT SECTION 2-25A “RESPONSIBLE CONTRACTORS,” TO  
ADD SUBSECTIONS (a)(4) AND (b)(4) “EXCLUSION”

The Council of Plymouth Township, Montgomery County, Pennsylvania, does hereby ENACT and ORDAIN that the Code of Ordinances of Plymouth Township, Pennsylvania, is hereby amended as stated below:

**SECTION 1. Amendment to Chapter 2 “Administration,” Section 2-25 “Responsible Contractors,” providing a new Subsection (a)(4) and (b)(4) “Exclusion.”**

The Township’s Code of Ordinances shall be amended at Chapter 2 “Administration,” Section 2-25 “Responsible Contractors,” to add Subsections (a)(4) and (b)(4) “Exclusion,” which shall read as follows:

**CHAPTER 2: ADMINISTRATION**

**Sec. 2-25A Responsible Contractors.**

(a)(4) To further effectuate the purpose of selecting responsible contractors for certain projects, specific exclusions shall be provided from the requirements of this Section.

(b)(4) Exclusion.

The Township may award a contract without application of the terms of this Section if all of the following apply:

- a. The work that is the subject of the contract is being completed by a public private partnership; and
- b. The funding for the work is supplied by both public and private sources; and
- c. The property is owned by the Township, but subject to a long term lease to a not-for-profit corporation.

**SECTION 2. Repeal and Ratification.**

All ordinances or parts of ordinances inconsistent herewith or in conflict with any of the specific terms enacted hereby, to the extent of said inconsistencies or conflicts, are hereby specifically

repealed. Any other terms and provisions of the Township's Code unaffected by this Ordinance are hereby reaffirmed and ratified.


**SECTION 3. Severability.**

Should any section, paragraph, sentence, clause, or phrase in this Ordinance be declared unconstitutional or invalid for any reason, the remainder of the Ordinance shall not be affected thereby and shall remain in full force and affect, and for this reason the provisions of this Ordinance shall be severable.
