ORDINANCE NO. 1981 STATE OF

MISSOURI

A SPECIAL ORDINANCE ADOPTING THE FISCAL YEAR 2023/2024 ANNUAL OPERATING AND CAPITAL BUDGET FOR THE CITY OF PLATTE CITY, MISSOURI AND AUTHORIZING THE EXPENDITURES OF FUNDS FOR MUNICIPAL SERVICES

WHEREAS, the City of Platte City has prepared a comprehensive budget for the fiscal year 2023/2024, reflecting anticipated revenues and expenditures; and

WHEREAS, it is necessary to formally adopt said budget in accordance with municipal regulations;

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF PLATTE CITY, MISSOURI, AS FOLLOWS:

- SECTION 1. That, for the purpose of financing the conduct of affairs of the City of Platte City, Missouri during the fiscal year from November 1, 2023 and ending on October 31, 2024, inclusive the budget of the City's revenue and expenses for such period prepared and submitted to the Platte City Board of Aldermen by the City Administrator is hereby approved and adopted as the Official Budget of the City of Platte City, Missouri; and
- **SECTION 2.** That, the amounts set forth in the various funds are hereby appropriated to such uses, and authority is hereby given to the City Administrator of the City of Platte City to expend the amounts shown for the purposes indicated; and
- SECTION 3. That, the amounts for each fund, as shown in the Annual Budget shall not be increased or decreased except by the Board of Aldermen approval, but the various objects of expenses comprising the total appropriation for any fund may be increased or decreased at the discretion of the City Administrator, providing the adjustments shall not increase the total amount appropriated for that fund.
- **SECTION 4.** That this bill is a Special Ordinance and is not to be incorporated into the Platte City, Missouri Code.
- **SECTION 5.** That this Ordinance shall be in full force and effect from and after its passage. All other ordinances or parts of ordinances in conflict herewith are hereby repealed.
- SECTION 6. SEVERABILITY– If any provision of this ordinance or its application to any person or circumstances are held invalid, the remainder of the ordinance or the application of the provisions to other persons or circumstances shall not be affected.

SECTION 4. EFFECTIVE DATE– This ordinance shall be in full force and effect September 26, 2023 after its passage.
