ORDINANCE OF THE CITY OF PLAINFIELD, COUNTY OF UNION, NEW JERSEY ADOPTING THE EAST 3RD STREET ENTERTAINMENT DISTRICT REDEVELOPMENT PLAN DATED APRIL 4, 2024

WHEREAS, on March 11, 2024, the City adopted Resolution 166-24 designating Block 308, Lot 1 (210-32 E. 3rd Street), Block 308, Lot 2 (234-42 E. 3rd Street), Block 308, Lot 3 (244-46 E. 3rd Street), Block 308, Lot 4 (248-52 E. 3rd Street) and Block 308, Lot 5 (254-56 E. 3rd Street) as a non-condemnation area in need of redevelopment (the "**Redevelopment Area**") in accordance with the Local Redevelopment and Housing Law, N.J.S.A. 40A:12A-1 et seq. (the "**Redevelopment Law**"); and

WHEREAS, thereafter the City Planning Board (the "**Planning Board**") caused Nishuane Group, LLC to prepare a redevelopment plan for the Redevelopment Area, dated April 4, 2024 and entitled "East 3rd Street Entertainment District Redevelopment Plan" (the "**Redevelopment Plan**"); and

WHEREAS, on April 4, 2024, at a duly noticed and constituted public meeting, the Planning Board reviewed and considered the Redevelopment Plan, which sets forth certain standards, uses and requirements within the Redevelopment Area; and

WHEREAS, after discussions and testimony, the Planning Board determined that the Redevelopment Plan is consistent with the City master plan and recommended the adoption of the Redevelopment Plan and on April 4, 2024 the Planning Board adopted a resolution memorializing their findings; and

WHEREAS, the City Council has reviewed the Redevelopment Plan and desires to adopt and implement the Redevelopment Plan in the form attached hereto as <u>Exhibit A</u>,

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Plainfield, in the County of Union, New Jersey, as follows:

Section 1. The aforementioned recitals are incorporated herein as though set forth at length.

Section 2. The Redevelopment Plan, as filed in the Office of the City Clerk, and attached hereto as <u>Exhibit A</u>, is hereby approved. The Redevelopment Plan supersedes the prior underlying zoning.

Section 3. The zoning map of the City of Plainfield is hereby amended to incorporate the provisions of the Redevelopment Plan.

Section 4. In case any one or more of the provisions of this Ordinance or the Redevelopment Plan shall, for any reason, be held to be illegal or invalid, such illegality or invalidity shall not affect any other provision of this Ordinance or the Redevelopment Plan, and this Ordinance shall be construed and enforced as if such illegal or invalid provision had not been contained herein.

Section 5. This Ordinance shall take effect as provided by law.
