**AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER 16A, ARTICLE 16A, SECTION 2-SCHEDULE II: NO PARKING CERTAIN HOURS ON BOTH SIDES OF STREET FOR ENTIRE BLOCK OF WEST END AVENUE FROM 10:00 AM TO 8:00 PM ON SATURDAY AND SUNDAY.**

**WHEREAS**, The City of Plainfield wishes to Amend and Add to the Ordinance language regarding No Parking Certain Hours on both sides of the street for the entire block of West End Avenue from 10:00 A.M. to 8:00 P.M and;

**WHEREAS**, residents of the below street have reported parking issues and concerns in this area and;

**WHEREAS**, the current language contained in the ordinance does not currently address this concern

**WHEREAS**, after a review by the City of Plainfield Police Department Traffic Unit, this recommendation is being recommended as a means of improving traffic safety on West End Ave and;

**NOW THEREFORE, BE IT ENACTED**, by the Municipal Council of the City of Plainfield, Union County, New Jersey, that the Vehicles and Traffic, Schedule 1 of Article 4, Section 16:A-2, Schedule II: No Parking Certain Hours, is hereby amended and added as follows:


**Chapter 16A, Article 16A, Section 2-Schedule II: No Parking**

<u>Name of Street</u>	<u>Sides</u>	<u>SCHEDULE 1: NO PARKING</u>
West End Avenue	Both Sides of Street	Entire length of West End Avenue

This Ordinance shall take effect after the final passage, twenty (20) days following action or inaction by the Mayor as provided by law, unless a resolution is adopted pursuant to N.J.S.A 40:69a181(b) declaring an emergency and providing that this Ordinance shall take effect at an earlier date.
