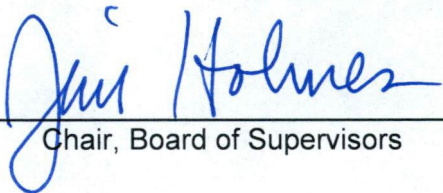

WHEREAS, Section 10.12.120 of the Placer County Code, Chapter 10, Article 10.12,
entitled Parking ("Parking Ordinance"), includes parking restrictions on various County
roads; and

WHEREAS, Section 22507 of the California Vehicle Code authorizes local authorities to
prohibit or restrict the stopping, parking, or standing of vehicles on or along public
roadways by adoption of an ordinance; and

WHEREAS, currently there are restricted parking signs and markings demarcating the
roadway segments where parking restrictions have been deemed appropriate; and

WHEREAS, the Department of Public Works engineering staff has reviewed locations
and distances for each parking restriction in the field, and recommends approval of all
locations and distances for each parking restriction included in this ordinance; and

WHEREAS, the Parking Ordinance amendments herein reflect the parking restrictions
currently existing and update the Placer County Code to reflect those parking
restrictions; and

WHEREAS, the Parking Ordinance amendments herein reflect the parking restrictions not currently existing and are proposed by County staff to be necessary parking restrictions.

THE BOARD OF SUPERVISORS OF THE COUNTY OF PLACER ORDAINS AS FOLLOWS:

Section 1: Placer County Code, Chapter 10, Article 10.12, Section 10.12.120 is amended with text to be removed shown in strikeout and underlined text to be added, and all revised road names to be ordered in alphabetical order, as follows:

10.12.120 Limitations imposed.

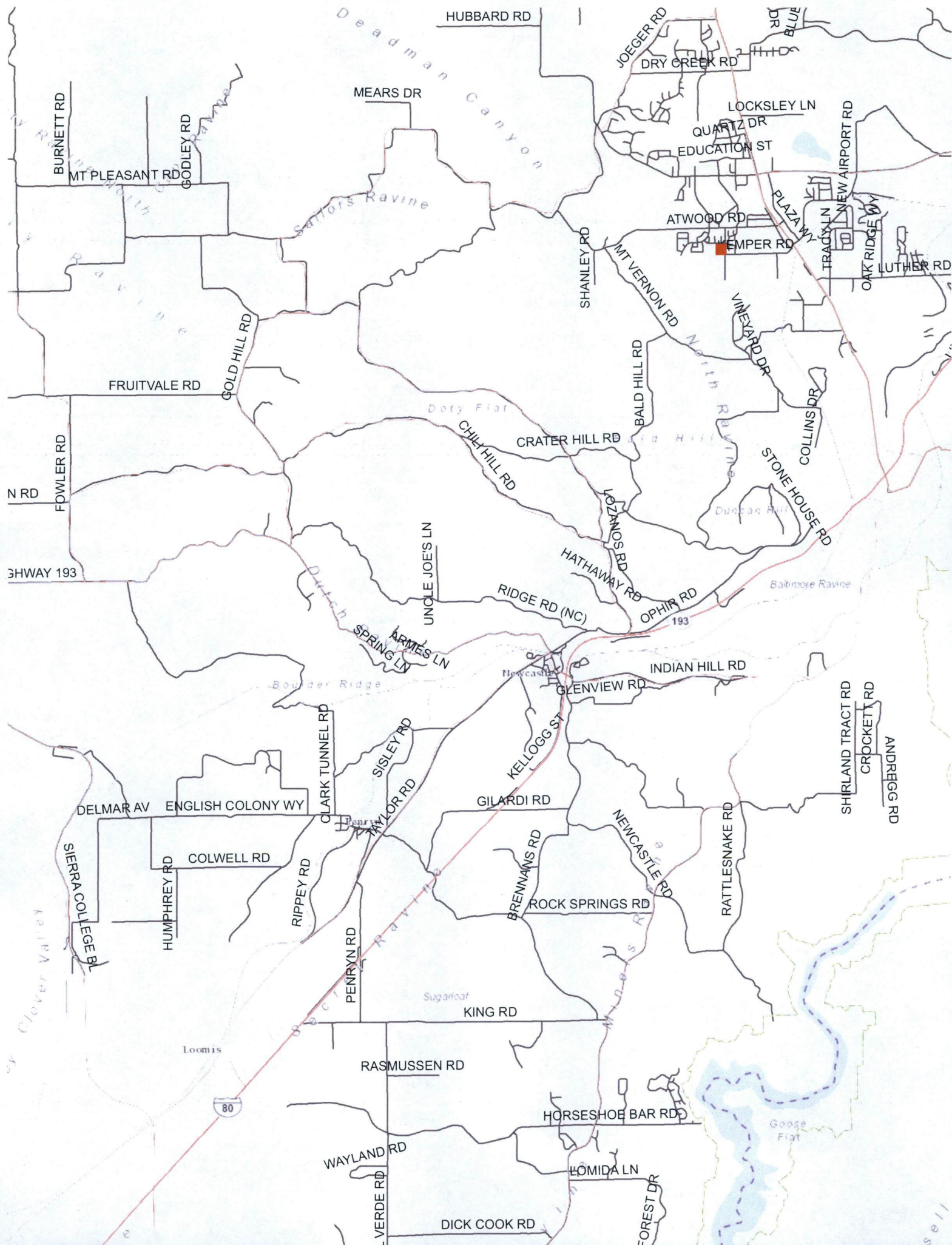
