

**POINT PLEASANT BOROUGH**

**ORDINANCE NO. 2024-04**

**ORDINANCE OF THE BOROUGH COUNCIL, BOROUGH OF POINT PLEASANT, COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING CHAPTER 3-1.9 ENTITLED “RESTRICTED USES AND ACTIVITIES - POLICE REGULATIONS” OF THE BOROUGH CODE**

**BE IT ORDAINED** by the Borough Council of the Borough of Point Pleasant, County of Ocean, State of New Jersey, (hereinafter referred to as the “Borough”) has reviewed numerous existing provisions in the Borough Code and finds the need to modify same as hereinbelow.

**SECTION 1.** Chapter 3-1.9 shall be modified and supplemented to include new paragraph h which will read as follows:

“All generator testing shall be performed weekdays between the hours of 8:00AM and 6:00PM.”

**SECTION 2.** All ordinances or parts of Ordinances inconsistent herewith are hereby repealed.

**SECTION 3.** If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

**SECTION 4.** This Ordinance shall take effect upon publication in an official newspaper of the Borough, as required by and in conformance with law.
