ORDINANCE NO. 2024-02

**ORDINANCE OF THE BOROUGH COUNCIL, BOROUGH OF
POINT PLEASANT, COUNTY OF OCEAN, STATE OF NEW
JERSEY, AMENDING AND SUPPLEMENTING CHAPTER 19
OF THE BOROUGH CODE ENTITLED “LAND USE”, §28.5(q)
OF THE BOROUGH CODE ENTITLED “DRIVEWAY
PROFILE”**

BE IT ORDAINED by the Borough Council of the Borough of Point Pleasant, County of Ocean, State of New Jersey, (hereinafter referred to as the “Borough”) that Chapter 19 of the Borough Code entitled “Land Use”, §28.5(q) entitled “Off Street Parking” be amended and supplemented which shall contain the following provisions:

SECTION 1. The Borough has adopted §28.5(q) of the Borough Code entitled “Driveway Profile”.

SECTION 2. Ribbon strips shall not be allowed on any driveways, either on commercial or residential properties.

SECTION 3. Ribbon strips are defined as two strips of concrete or other impervious surfaces with a grass, stone, or other pervious cover between them.

SECTION 4. All ordinances or parts of Ordinances inconsistent herewith are hereby repealed.

SECTION 5. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

SECTION 6. This Ordinance shall take effect upon publication in an official newspaper of the Borough, as required by and in conformance with law.
