#### **ORDINANCE NO. 24-09**

#### AN ORDINANCE AMENDING CHAPTER 7, SECTION 7-33, "MID-BLOCK CROSSWALKS", OF THE MUNICIPAL CODE OF THE BOROUGH OF POMPTON LAKES TO ESTABLISH CROSSWALKS

**BE IT ORDAINED** by the Mayor and Council of the Borough of Pompton Lakes, Passaic County, New Jersey, as follows:

**Section 1.** Chapter 7, Section 7-33, "Mid-Block Crosswalks", of the Municipal Code of the Borough of Pompton Lakes, is hereby amended to add the following crosswalks:

| Lincoln Avenue at Lincoln School | Beginning at a point on the face of curb on the Easterly side of Lincoln Avenue, said beginning point having a New Jersey State Plane Coordinate of North: 786471.4905, East: 551720.8892. Said point also being located 443+/- feet as measured along the Easterly face of curb on Lincoln Avenue as presently constructed from the point of intersection with the Northerly face of curb on Riverview Road, and running thence; (1) North 76 degrees 35 minutes 27 seconds West for a distance of 40.00 feet to a point on the Westerly face of curb on Lincoln Avenue, thence; (2) Along the Westerly curb line on Lincoln Avenue, North 13 degrees 54 minutes 26 seconds East for a distance of 10.00 feet to a point, thence; (3) On a line parallel to the first course, South 76 degrees 35 minutes 27 seconds East for a distance of 40.00 feet to a point on the Easterly face of curb on Lincoln Avenue, thence; (4) Along the Easterly curb line on Lincoln Avenue, South 13 degrees 54 minutes 26 seconds West for a distance of 10.00 feet to the point and place of beginning as herein described. |
| Lenox Avenue at Lenox School     | Beginning at a point on the Northerly face of the curb line located on Lenox Avenue, said point having a New Jersey State Plane Coordinate of North: 790405.1452, East: 550182.0276. Said point also being located South 81 degrees 18 minutes 00 seconds West 539 +/- feet along the Northerly curb line of Lenox Avenue from the Westerly curb line of Ramapo Avenue, and running thence; (1) South 08 degrees 42 minutes 00 seconds East for a distance of 30.00 feet to a point, thence; (2) Along the Southerly curb line on Lenox Avenue, South 81 degrees 18 minutes 00 seconds West for a distance of 10.00 feet to a point, thence; (3) On a line parallel to the first course, North 08 degrees 42 minutes 00 seconds West for a distance of 30.00 feet to a point, thence; (4) Along the Northerly curb line on Lenox Avenue, North 81 degrees 18 minutes 00 seconds East for a distance of 10.00 feet to the point and place of beginning as herein described.   |

The Morris Canal Greenway Known as Ventimiglia West & Ventimiglia East Lincoln Avenue

Beginning at a point on the Easterly face of the curb line located on Wanaque Avenue, said point having a New Jersey State Plane Coordinate of North: 791076.1669, East: 549640.3817. Said point also being located South 07 degrees 12 minutes 55 seconds West 178 +/- feet along the Easterly curb line on Wanague Avenue from the Southerly curb line of Colfax Avenue, and running thence; (1) Along the Easterly curb line on Wanaque Avenue, South 07 degrees 12 minutes 55 seconds West for a distance of 7.00 feet to a point, thence; (2) North 83 degrees 53 minutes 55 seconds West for a distance of 38.00 feet to a point, thence; (3) Along the Westerly curb line on Wanaque Avenue, North 07 degrees 12 minutes 55 seconds East for a distance of 7.00 feet to a point, thence; (4) On a line parallel to the second course, South 83 degrees 53 minutes 55 seconds East for a distance of 38.00 feet to the point and place of beginning as herein described.

Beginning at a point on the Westerly face of a curb line on Lincoln Avenue, said point having a New Jersey State Plane Coordinate of North: 782736.3337, East: 551980.0444. Said point also being located South 08 degrees 58

minutes 50 seconds East 445 +/- feet along the Westerly curb line on Lincoln Avenue from the Southerly curb line of Poplar Avenue, and running thence;

- (1) North 79 degrees 43 minutes 23 seconds East for a distance of 30.00 feet to a point, thence;
- (2) Along the Easterly curb line of Lincoln Avenue, South 08 degrees 53 minutes 50 seconds East for a distance of 7.00 feet to a point, thence;
- (3) On a line parallel to the first course, South 79 degrees 43 minutes 23 seconds West for a distance of 30.00 feet to a point, thence;
- (4) Along the Westerly curb line of Lincoln Avenue, North 08 degrees 53 minutes 50 seconds West for a distance of 7.00 feet to the point and place of beginning as herein described.
- **Section 2**. All ordinances or parts of ordinances or resolutions that are in conflict with the provisions of this Ordinance are repealed to the extent necessary.
- **Section 3**. If any article, section, subsection, term or condition of this Ordinance is declared invalid or illegal for any reason, the balance of the Ordinance shall be deemed severable and shall remain in full force and effect.
