# **ORDINANCE NO. 24-13**

AN ORDINANCE AMENDING CHAPTER 4 OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF POMPTON LAKES AND ESTABLISHING FEES FOR DOG PARK AND POMPTON DAY SPONSORSHIPS AND FEES FOR VENDORS AT PUBLIC EVENTS

**WHEREAS,** the Borough has established a sponsorship program to support the dog park through the purchase of advertising signs and it is necessary to establish the sponsorship fees by ordinance; and

**WHEREAS**, it is also necessary to establish vender fees for public events by ordinance.

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and Council of the Borough of Pompton Lakes, County of Passaic and State of New Jersey as follows:

**Section 1.** Chapter 4 of the Municipal Code of the Borough of Pompton Lakes, shall be amended by the inclusion of new Article IV, which shall be entitled "Fees for Vendors at Public Events" which shall read, in its entirety, as follows:

### Article IV Fees for Vendors at Public Events

#### §4-4 Fees for Vendors at Public Events

**§4-4.1.** The fee for vendors at Pompton Day shall be as follows:

\$35.00 Non-profit entity \$70.00 Single \$95.00 Double \$125.00 Food \$125.00 RV

**Section 2.** Chapter 4 of the Municipal Code of the Borough of Pompton Lakes, shall be amended by the inclusion of new subsections 4-3.2 and 4.3.3 which shall read, in their entirety, as follows:

**§4-3.2 Dog Park Sponsorship.** The fee for sponsorship of advertising signs at the Dog Park shall be as follows:

\$150.00 Single Season Sponsorship. \$350.00 Two Season Sponsorship. \$500.00 Three Season Sponsorship

**§4-3.2 Pompton Day Sponsorship.** The fee for sponsorship of advertising signs at Pompton Day shall be as follows:

\$ 75.00 for 24" x 18"Half Size Single Sided Sign Sponsorship \$150.00 for 24" x 36" Full Size Single Sided Sign Sponsorship. \$250.00 for 24" x 36" Full Size Double Sided Sign Sponsorship. \$300.00 for 60" x 36" Single Sided Banner Sponsorship

**Section 3**. All ordinances or parts of ordinances or resolutions that are in conflict with the provisions of this Ordinance are repealed to the extent necessary.

**Section 4**. If any article, section, subsection, term or condition of this Ordinance is declared invalid or illegal for any reason, the balance of the Ordinance shall be deemed severable and shall remain in full force and effect.

**Section 5**. This Ordinance shall take effect after approval of the Mayor or in accordance with law and publication and passage according to law.
