Ordinance 2024-09

**ORDINANCE ADDRESSING COOLERS ON BEACHES WITHIN THE BOROUGH OF
POINT PLEASANT BEACH**

WHEREAS, the Borough of Point Pleasant Beach (“Borough”) maintains Ordinance § 21-1.4 establishing Prohibited Acts upon beaches located within the Borough; and

WHEREAS, the Borough seeks to make revisions to the regulation of coolers under said provision.

NOW, THEREFORE, BE IT ORDAINED by the Borough Council of the Borough of Point Pleasant Beach in the County of Ocean, State of New Jersey, as follows:

**SECTION I. Chapter 21, titled “Beaches” of the Point Pleasant Beach
Municipal Code is hereby amended and supplemented as follows:**

§ 21-1.4 Prohibited Acts

No person shall do any of the following things at or upon the boardwalk and/or beaches or the ocean waters located in the Borough:

a.-k. [No changes].

l. Bring any of the following onto a beach:

1. Coolers larger than 18 inches in length, 12.5 inches in width, and 15.5 inches in height and/or has a capacity greater than 28 quarts.

2.-7. [No changes].

m.-n. [No changes].

SECTION 2. Severability.

The provisions of this Ordinance shall be severable. In the event that any portion of this Ordinance is found to be invalid for any reason by any Court of competent jurisdiction, such judgment shall be limited in its effect only to the portion of the Ordinance actually adjudged invalid and shall not be deemed to affect the operation of any other portion thereof, which shall remain in full force and effect.

SECTION 3. Repealer.

All ordinances and resolutions, and parts of ordinances and resolutions which are inconsistent with provisions of this ordinance shall be, and are hereby, repealed to the extent of any such inconsistency.

SECTION 4. Effective Date.

This ordinance shall take effect upon final adoption and publication in accordance with law.
