## **ORDINANCE NO. 1365**

## AMENDING CHAPTER 33 OF THE PROSPECT PARK BOROUGH CODE GOVERNING THE ADMINISTRATION OF THE RECREATION BOARD

**WHEREAS**, the Prospect Park Borough Code, Chapter 33, establishes and governs the administration of the Recreation Board in the Borough of Prospect Park; and,

**WHEREAS**, the Borough Council of the Borough of Prospect Park has placed an emphasis on improving the quality of life services that it provides to the residents and taxpayers of the Borough, including providing enhanced parks and recreation facilities, activities and events to our citizens; and,

**WHEREAS**, the Borough Council desires that a Recreation Board increase its activity in assisting the Borough Council in administering the parks and recreation facilities, activities and events in the Borough; and,

**WHEREAS**, the Borough Council believes that amending the Prospect Park Borough Code provisions governing the administration of the Recreation Board would strengthen that Board and enhance the health, safety and welfare of the residents and taxpayers of the Borough;

**NOW THEREFORE, BE IT ORDAINED** by the Borough Council of the Borough of Prospect Park as follows:

- **SECTION 1.** Amendment to Part I, Chapter 33 of the Prospect Park Borough Code, Recreation Board
- Part I Administrative Legislation, Chapter 33 of the Prospect Park Borough Code is hereby amended, as follows:
- A. Section 33-2, governing membership of the Board and terms of office, is hereby amended to provide that the Prospect Park Recreation Board shall consist of seven (7) members and that the term of each member shall be two (2) years and until a successor is appointed.
- B. Section 33-4, governing the powers and duties of the Board, is hereby amended to add the following provision:

F. create such subcommittee(s) of the Board as may be necessary to promote the administration of recreational activities in the Borough and appoint such volunteers to such subcommittee(s) as may be appropriate.

**SECTION 2**. Any provision of the Prospect Park Borough Code not affected by the amendments stated in Section 1 above shall remain in full force and effect.

**SECTION 3.** All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

**SECTION 4.** The invalidity of any Section, clause, sentence, or provision of this Ordinance shall not affect the validity of any other part of this Ordinance, which can be given effect without such invalid part or parts. It is hereby declared to be the intention of the Borough that this Ordinance would have been adopted had such invalid Section, clause, sentence, or provision not been included therein.

**SECTION 5**. This Ordinance shall become effective immediately upon enactment.
