

**CITY OF PROSSER, WASHINGTON  
ORDINANCE NO. 26-3312**

**AN ORDINANCE APPROVING BUDGET AMENDMENT NUMBER TWO AMENDING THE 2026 BUDGET AT THE FUND LEVEL TO ALLOW FOR THE EXPENDITURE OF FUNDS RELATED TO THE FUNDING PROVIDED BY THE EDGAR WHITEHEAD FOUNDATION FOR THE PURCHASE OF A FIELD PAINTER; AND FINDS THAT AMENDMENT TO THE 2026 BUDGET IS IN THE BEST INTEREST OF THE CITY. THE ORDINANCE ALSO AUTHORIZES THE FINANCE DIRECTOR TO MAKE ALL ADJUSTMENTS TO THE 2025 BUDGET ORDINANCE NECESSARY TO ACCOMPLISH THE PURPOSE OF THIS ORDINANCE. THE ORDINANCE ALSO PROVIDES THAT SECTIONS ARE SEVERABLE FROM ONE ANOTHER AND SETS FORTH THE EFFECTIVE DATE OF THE ORDINANCE AND PROVIDES FOR PUBLICATION BY SUMMARY.**

**WHEREAS**, the 2026 adopted budget included an estimated cash balance and funds were received in excess of those estimates; and

**WHEREAS**, the city has been awarded \$7,000 by the Edgar Whitehead Foundation to support the purchase of a field painter; and

**WHEREAS**, the Council finds that it is in the best interest of the City of Prosser to appropriate a portion of the unexpended fund balance and release those funds for appropriation pursuant to RCW 35A.33.120; and

**THE CITY COUNCIL OF THE CITY OF PROSSER, WASHINGTON, DO ORDAIN AS FOLLOWS:**

**Section 1.** The 2026 Budget is amended at the fund level as follows:

**Section 2.** The Finance Director is hereby authorized to make all adjustments to the City's Budget to accomplish the purposes of this Ordinance in accordance with RCW Chapter 35A.33.120 and in accordance with the BARS Manual.

**Section 3.** The Finance Director is hereby authorized to close this fund when it is deemed to be no longer necessary and in the best interest of the City. Required submittals, reimbursement

requests, and other required reports may also be submitted administratively by the Finance Director. Additionally, the Finance Director is authorized to make transfers, interfund loans, and other transfers necessary in order to carry out the intent of this ordinance and amendment.

**Section 4. SEVERABILITY.** The provisions of this ordinance are hereby declared to be severable. If any section, subsection, sentence, clause, or phrase of this ordinance or its application to any person or circumstance is for any reason held to be invalid or unconstitutional, the remainder of this ordinance shall not as a result of said section, subsection, sentence, clause, or phrase be held unconstitutional or invalid.

**Section 5.** This ordinance shall take effect five days after passage and publication of an approved summary thereof consisting of the title.


