

**CITY OF PROSSER, WASHINGTON  
ORDINANCE NO. 26-3315**

**AN ORDINANCE UPDATING AND REPLACING PREVIOUSLY ADOPTED FEES FOR VARIOUS CITY SERVICES. FEES ESTABLISHED BY PREVIOUS FEE ORDINANCES SHALL CONTINUE TO APPLY TO ALL CITY SERVICES PROVIDED BEFORE THE EFFECTIVE DATE OF THIS ORDINANCE, AND ADOPTING THE FEES SCHEDULE BY REFERENCE.. THE ORDINANCE ALSO MAKES THE PROVISIONS OF THE ORDINANCE SEVERABLE FROM ONE ANOTHER, PROVIDES FOR PUBLICATION OF A SUMMARY OF THIS ORDINANCE, AND SETS FORTH THE EFFECTIVE DATE OF THE ORDINANCE.**

**THE CITY COUNCIL OF THE CITY OF PROSSER, WASHINGTON, DO ORDAIN AS FOLLOWS:**

**Section 1.** The fees for various City services previously adopted are hereby replaced by Fee Schedule attached hereto and incorporated herein is fully set forth and is hereby adopted in it's entirety.

**Section 2.** The fees established by previous fee ordinances shall continue to apply to all City services provided before the effective date of this ordinance. The fees set by Ordinance Number 18-3080 shall continue to apply to all public records requests submitted before the effective date of this Ordinance.

**Section 3. Severability.** The provisions of this ordinance are hereby declared to be severable. If any section, subsection, sentence, clause, or phrase of this ordinance or its application to any person or circumstance is for any reason held to be invalid or unconstitutional, the remainder of this ordinance shall not as a result of said section, subsection, sentence, clause, or phrase be held unconstitutional or invalid.

**Section 4.** This ordinance shall take effect five days after passage and publication of an approved summary thereof consisting of the title.

**SUMMARY OF ORDINANCE NO. 26-3315**

of the City of Prosser, Washington

On the 23rd day of June, 2026, the City of Prosser, Washington, passed Ordinance No. 26-3315. A summary of the content of said ordinance, consisting of the title, provides as follows:

AN ORDINANCE UPDATING AND REPLACING PREVIOUSLY ADOPTED FEES FOR VARIOUS CITY SERVICES. FEES ESTABLISHED BY PREVIOUS FEE ORDINANCES SHALL CONTINUE TO APPLY TO ALL CITY SERVICES PROVIDED BEFORE THE EFFECTIVE DATE OF THIS ORDINANCE, AND ADOPTING THE FEES SCHEDULE BY REFERENCE. THE ORDINANCE ALSO FINDS THAT IT WOULD BE AN UNDUE BURDEN AS PROVIDED FOR IN RCW 42.56.120(2)(B) TO CALCULATE THE ACTUAL COSTS FOR SCANNED PAGES, ELECTRONIC DOCUMENTS EXCEPT AS PROVIDED FOR IN SECTION 4 OF THIS ORDINANCE, AND STANDARD BLACK AND WHITE COPIES, BECAUSE THE CITY LACKS SUFFICIENT STAFF TO TRACK AND THEN BILL FOR THE ACTUAL COSTS OF REPRODUCTION OF THOSE RECORDS. THE ORDINANCE ALSO MAKES THE PROVISIONS OF THE ORDINANCE SEVERABLE FROM ONE ANOTHER, PROVIDES FOR PUBLICATION OF A SUMMARY OF THIS ORDINANCE, AND SETS FORTH THE EFFECTIVE DATE OF THE ORDINANCE.
