

**BOROUGH OF RARITAN**  
**ORDINANCE NO. 2025-19**

**AN ORDINANCE REPEALING CHAPTER 45, ENTITLED  
“PERSONNEL POLICIES” OF THE RARITAN BOROUGH CODE,  
IN ITS ENTIRETY**

**WHEREAS**, the Borough Council of the Borough of Raritan, County of Somerset, State of New Jersey wishes to repeal Chapter 45 – Personnel Policies – of the Raritan Borough Code; and

**WHEREAS**, the reason for such repeal is to give the Council greater flexibility in adopting personnel policies in the future without the need for a formal ordinance adoption; and

**WHEREAS**, the Borough Council believes that the repeal of Chapter 45 in its entirety is in the best interest of the Borough and its residents.

**NOW, THEREFORE, BE IT ORDAINED** by the Borough Council of the Borough of Raritan, County of Somerset, State of New Jersey that Chapter 45 – Personnel Policies – of the Raritan Borough Code is hereby repealed in its entirety.

**SECTION I:**

All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed to the extent of such inconsistencies.

**SECTION II:**

If any article, section, subsection, paragraph, phrase or sentence of this ordinance is, for any reason, declared to be unconstitutional or invalid, such article, section, subsection, paragraph, phrase or sentence shall be deemed severable.

**SECTION III:**

This ordinance shall take effect immediately upon final publication as provided by law.


