AN ORDINANCE BY THE CITY OF RAHWAY AUTHORIZING THE INSTALLATION OF A FOUR WAY STOP AT THE INTERSECTION OF JEFFERSON AVENUE AND STONE STREET AND AMENDING THE CODE OF THE CITY OF RAHWAY

WHEREAS, N.J.S.A. 39:5A-1 provides that a municipality may make, amend, repeal, and enforce ordinances to regulate vehicular and pedestrian traffic and the parking of vehicles in parking yards and parking places, which are open to the public or to which the public is invited in conjunction with any business enterprise.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Rahway, County of Union, State of New Jersey that Chapter 401 of the General Code of the City of Rahway, more particularly Article X, Schedules, § 401-85, "Schedule XXVI: Four Way Stop Intersections" and Article X, Schedules, § 401-65, "Schedule VI: Through Streets" are hereby amended and supplemented as follows:

Language that remains unchanged is not highlighted in anyway

SECTION I

§ 401-85 Schedule XXVI: Four Way Stop Intersections

Pursuant to the provisions of N.J.S.A. 39:4-140 (§ 401-12), intersections described are hereby designated as multistop intersections. Stop signs shall be installed as provided therein.

Intersection	Stop Sign On
Maple Avenue and Jefferson Avenue [Added 4-12-1999 by Ord. No. O-5-99]	All four approaches
West Inman Avenue and Jaques Avenue	All four approaches
West Lake Avenue and Madison Avenue [Added 6-11-2018 by Ord. No. O-08-18]	All four approaches
<u>Jefferson Avenue and Stone Street</u>	<u>All four approaches</u>

SECTION II

§ 401-65 Schedule VI: Through Streets

In accordance with the provisions of § 401-10, the following described streets or parts of streets are hereby designated as through streets. Stop signs shall be installed on the near right side of each street intersecting the through street, except where yield signs are provided for in the designations.

[no changes between Allen Street and Seminary Avenue]

Jefferson Avenue

From Colonia Boulevard to West Inman Avenue; thence, from West Inman Avenue to West Lake Avenue; thence, from West Lake Avenue to Maple Avenue; thence, from Maple Avenue to Stone Street; thence, from Stone Street to Westfield Avenue

[no changes from Thorn Street to Whittier Street]

SECTION III

SEVERABILITY. If any section, subsection, sentence, clause, or phrase of this Ordinance is for any reason held to be invalid or unconstitutional, such decision shall not affect the remaining portions of this Ordinance, which shall otherwise remain in full force and effect.

SECTION IV

REPEALER. All ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.

SECTION V

EFFECTIVE DATE. This Ordinance shall take effect immediately upon its passage and publication in accordance with the law.
