THE COMMISSIONERS OF THE CITY OF REHOBOTH BEACH ON JULY 19, 2024, ADOPTED ORDINANCE NO. 0724-01 WHICH READS AS FOLLOWS:

AN ORDINANCE TO THE CITY OF REHOBOTH BEACH CODE CHAPTER 92 SECTION 264 SPECIAL CONSIDERATIONS AND EXCEPTIONS, CHAPTER 95 SECTION 12 DEFINITIONS, CHAPTER 195 SECTION 1 DEFINITIONS, AND CHAPTER 224 SECTION 2 SMOKING TOBACCO PRODUCTS PROHIBITED.

**BE IT ORDAINED**, by the Commissioners of the City of Rehoboth Beach, in session met, in the manner following to wit:

**Section 1.** Chapter 92, Subsection 264, of the Municipal Code of the City of Rehoboth Beach, Delaware, 2001, as amended be and the same is hereby further amended by making insertions as shown by underlining and deletions as shown by strikethrough, as follows:

## § 92-264 Special considerations and exceptions.

**Section 2.** Chapter 95, Subsection 12, of the Municipal Code of the City of Rehoboth Beach, Delaware, 2001, as amended be and the same is hereby further amended by making insertions as shown by underlining and deletions as shown by strikethrough, as follows:

## § 95-12 Definitions.

As used in this article, the following terms shall have the meanings indicated:

#### **SECTION I**

The entire beach from the north side of Maryland Avenue to the north side of Pennsylvania Avenue.

**Section 3.** Chapter 195, Subsection 1, of the Municipal Code of the City of Rehoboth Beach, Delaware, 2001, as amended be and the same is hereby further amended by making insertions as shown by underlining and deletions as shown by strikethrough, as follows:

## § 195-1 Definitions.

As used in this chapter, the following terms shall have the meanings indicated:

#### **PARK**

An area of land with an individual name that is owned and/or managed by the City of Rehoboth Beach and is used by the public for rest and/or recreation. Parks include Mariner's (Surfside) Park, Lewes-Rehoboth Canal bank, Central Park, Grove (Shaw) Park, Grove Park Canal Dock, Deer Park, Stockley Street (Country Club Estates) Park,

Cranberry Park, Lake Gerar Park, Lee Street Park, Teardrop (Silver Lane) Park, and Martin's Lawn Park.

**Section 4.** Chapter 224, Subsection 2, of the Municipal Code of the City of Rehoboth Beach, Delaware, 2001, as amended be and the same is hereby further amended by making insertions as shown by underlining and deletions as shown by strikethrough, as follows:

# § 224-2 Smoking tobacco product prohibited.

I. The Beach, defined for purposes of this chapter as the area of the City east of Ocean Drive, Surf Avenue and the Boardwalk extending 100 yards east of the high-water line of the Atlantic Ocean; except smoking shall be permitted on the Beach in designated and marked locations as determined by the City Manager, subject to the following:

**Section 5.** This Ordinance shall become effective immediately upon its adoption by the Commissioners of the City of Rehoboth Beach.

SYNOPSIS: This ordinance removes references to Deauville Beach as they relate to parking, beach concessions, park rules and regulations, and smoking.
