According to the annexed opinion of the Corporation Counsel, the City Budget was not adopted according to appropriate procedures.

Based on this opinion, no legal Budget has been passed. Consequently, I cannot sign the Budget resolution submitted, and must reject the Budget in its entirety, until such time it is presented to me following appropriate procedures.

Assuming the Budget submitted previously to me is essentially the Budget I will receive again, I will reject some items, and the Council will have to act to override.
