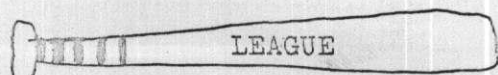
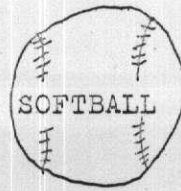
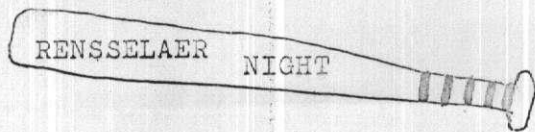
Alderman *Lithgow* moved to adjourn, seconded by Alderman *Adams*
