ORDINANCE PRESCRIBING REGULATIONS FOR THE CONTROL OF PARKING ON THE EAST SIDE OF SPRUCE STREET IN THE CITY OF RENSSELAER FROM THE POINT OF INTERSECTION WITH THE PARKING AREA FOR THE AIKEN AVENUE HOUSING PROJECT SOUTHERLY ALONG THE EAST SIDE OF STREET TO THE END OF SAID STREET

THE CITY OF RENSSELAER IN COMMON COUNCIL CONVENED DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1. ON AND AFTER THE EFFECTIVE DATE OF THIS ORDINANCE SPRUCE STREET ON THE EAST SIDE THEREFORE COMMENCING AT A POINT OF THE PARKING AREA FOR THE AIKEN AVENUE HOUSING PROJECT SOUTHERLY TO THE END OF SAID SPRUCE STREET IS DESIGNATED AS A FIRE LANE AND IT SHALL BE UNLAWFUL AT ANY TIME TO PARK ANY VEHICLE ON OR ALONG SAID PORTION OF SAID STREET.

SECTION 2. THIS ORDINANCE SHALL TAKE EFFECT IMMEDIATELY AFTER PUBLICATION FOR TWO SUCCESSIVE WEEKS IN THE OFFICIAL NEWSPAPER.
