A meeting of the Village of Red Hook Board of Trustees was convened in public session at the Village Hall, 7467 South Broadway, Red Hook, NY on March 23, 2026. The meeting was called to order by Mayor Smythe.

A RESOLUTION SUPPORTING A SCHOOL SPEED ZONE FOR LINDEN AVENUE MIDDLE SCHOOL (LAMS) AND RED HOOK HIGH SCHOOL (RHHS).

WHEREAS, the safety of our students is of paramount concern to the Village of Red Hook; and
WHEREAS, there is currently no School Speed Zone around LAMS or RHHS, both located in the Village of Red Hook; and

WHEREAS, both LAMS & RHHS have entrances on State Route 199, and LAMS has an entrance on County Route 79 (Linden Avenue).

The Board of Trustees of the Village of Red Hook supports the proposal to create a school speed zone on State Route 199 and County Route 79 (Linden Avenue).
