**A RESOLUTION OF THE COUNCIL OF THE BOROUGH
OF RED LION, YORK COUNTY, PENNSYLVANIA,
AMENDING THE GENERAL BOROUGH FEE SCHEDULE**

WHEREAS, Red Lion Borough sets forth fees as established by separate resolutions of the Borough Council; and

WHEREAS, the Borough Council adopted a revised General Fee Schedule to incorporate all existing fees into one resolution; and

WHEREAS, the Borough Council wishes to amend the General Fee Schedule to incorporate revised fees;

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of Red Lion, York County, Pennsylvania, that a revised General Borough Fee Schedule as set forth in Exhibit "A", attached hereto and incorporated herein is hereby adopted; and

BE IT FURTHER RESOLVED that these General Borough Fee Schedule shall become effective immediately and remain in effect thereafter until further revised; and


FURTHER RESOLVED, that any and all resolutions or parts of resolution in conflict herewith are hereby repealed.

<u>Amusement devices:</u>	\$25.00/year mechanical \$50.00/year electronic
<u>Certificate of Use:</u>	\$25.00
<u>Copies:</u>	\$0.25 per page
<u>Dogs Running at Large:</u>	\$50.00
<u>Excavation Permit:</u>	\$11.00 per square foot for streets resurfaced less than 2 years \$9.00 per square foot for streets resurfaced more than 2 years and less than 5 years \$5.50 per square foot for streets resurfaced more than 5 years
Bonding:	\$30.00 per square yard renewed annually
Insurance:	Property damage, liability per person and liability each accident. Red Lion Borough listed as Certificate Holder in the amount of \$1,000,000
Longitudinal openings more than 10 feet require full lane bituminous overlay for the length of the cut.	
More than 2 transverse cuts less than 30 feet apart require full lane bituminous overlay for the length of the cut.	
More than 5 cuts within 10 feet of each other or within a 75 foot radius shall be restored as one opening.	
<u>Grass Cutting of Ordinance Violators:</u>	\$200.00 minimum (Includes fee for mowers, edger, weed control and labor)
<u>Hall Rental</u>	\$200.00 for 3 hours + additional \$50 for kitchen. Security deposit (refundable) \$100.00
<u>Lien Costs:</u>	\$350.00 legal fee and 4.5% interest
<u>Meter Bag Rental w/Permit:</u>	\$30.00 per bag (maximum 2 bags) (maximum 5 days)
<u>Non-Vehicular Object in Street Permit:</u> (Dumpster, Storage Container, Etc.)	\$15.00 per day (maximum 15 days)
<u>Parking Fee on West Broadway Parking Lot:</u>	\$0.25 per half hour
