

**ORDINANCE NO. 2023-09**

**ORDINANCE OF THE BOROUGH OF RED BANK, COUNTY OF MONMOUTH, NEW JERSEY AMENDING AND SUPPLEMENTING SECTION 680-35, SCHEDULE IV: TIME-LIMITED PARKING**

**BE IT ORDAINED** by the Governing Body of the Borough of Red Bank that Section 680-35, Schedule I: No Parking, is hereby amended and supplemented as follows:

**SECTION ONE:**

Schedule I: No Parking is amended and supplemented as follows: (*strikeouts denote deletions, underlined text denotes additions*):

**SCHEDULE I**

**No Parking**

In accordance with the provisions of Section 680-35, no person shall park a vehicle at any time upon any of the following described streets or parts of streets.

Spring Street	East	Between East Front Street and <del>the Red Bank Borough-Little Silver Borough line</del> <u>Harding Road</u>
<u>Spring Street</u>	<u>West</u>	<u>Between Harding Road and the Red Bank-Little Silver Borough line</u>

**SCHEDULE IV**

**Time-Limited Parking**

In accordance with the provisions of § 680-3F, no person shall park a vehicle for longer than the time limit shown on any of the following streets or parts of streets.


Name of Street	Sides	Time Limit	Hours	Location
<u>Spring Street</u>	<u>East</u>	<u>3 hour</u>	<u>8AM to 6PM</u>	<u>Between Harding Road and the Red Bank-Little Silver Borough line</u>
<u>Highland Avenue</u>	<u>Both</u>	<u>3 hour</u>	<u>8AM to 6PM</u>	<u>Entire length</u>

**SECTION TWO:** Any ordinances or portions thereof which are inconsistent with the provisions of this Ordinance are hereby repealed as of the effective date of this Ordinance.

**SECTION THREE:** If any provision of this Ordinance or the application of such provision to any person or circumstance is declared invalid, such invalidity shall not affect the other provisions or applications of this Ordinance which can be given effect, and to this end, the provisions of this Ordinance are declared to be severable.

**SECTION FOUR:** This Ordinance shall take effect immediately upon its passage and adoption according to law.
