ORDINANCE OF THE BOROUGH OF RED BANK, COUNTY OF MONMOUTH, NEW JERSEY AMENDING AND SUPPLEMENTING CHAPTER 680, "VEHICLES AND TRAFFIC," SECTION 680-42, "SCHEDULE VIII: "STOP INTERSECTIONS"

BE IT ORDAINED by the Governing Body of the Borough of Red Bank that Chapter 680 of the Revised General Ordinances of the Borough of Red Bank, Monmouth County, "Vehicles and Traffic," Section 680-42 Schedule VIII, "Stop Intersections," is hereby amended and supplemented as follows:

SECTION ONE: Schedule VIII, "Stop Intersections," is amended and supplemented as follows: (strikeouts denote deletions, underlined text denotes additions):

SCHEDULE VIII: No Stopping or Standing

In accordance with the provisions of § 680-6B, the following intersections are hereby designated as stop intersections:

Intersections

Stop Sign On

Drs. James Parker Boulevard and Leighton Avenue All approaches

[All other provisions remain unchanged]

SECTION TWO: Any ordinances or portions thereof which are inconsistent with the provisions of this Ordinance are hereby repealed as of the effective date of this Ordinance.

SECTION THREE: If any provision of this Ordinance or the application of such provision to any person or circumstance is declared invalid, such invalidity shall not affect the other provisions or applications of this Ordinance which can be given effect, and to this end, the provisions of this Ordinance are declared to be severable.

SECTION FOUR: This Ordinance shall take effect immediately upon its passage and adoption according to law.
