

ORDINANCE NO. NP2023-14

ORDINANCE OF THE BOROUGH OF RED BANK, COUNTY OF MONMOUTH, NEW JERSEY AMENDING AND SUPPLEMENTING CHAPTER VII, "TRAFFIC," SECTION 7-3.9, "PERMIT PARKING IN DESIGNATED AREAS," SCHEDULE XIX, "RESIDENTIAL PARKING DISTRICT NUMBER TWO"

BE IT ORDAINED by the Governing Body of the Borough of Red Bank that Chapter VII of the Revised General Ordinances of the Borough of Red Bank, Monmouth County, "TRAFFIC," Section 7-3.9, "Permit Parking in Designated Areas," Schedule XIX, "Residential Parking District Number Two" is hereby amended and supplemented as follows:

SECTION ONE:

a. Section 7-3.9, Schedule XIX, "Permit Parking, Residential Parking District Number Two" is amended and supplemented as follows (strikeouts denote deletions, underlined text denotes additions):

**SCHEDULE XIX
PERMIT PARKING**

In accordance with the provisions of Subsection 7-3.9, the following streets or parts of streets are designated for permit parking by residents.

RESIDENTIAL PARKING DISTRICT NUMBER ONE

RESIDENTIAL PARKING DISTRICT NUMBER TWO

Name of Street	Side	Location	<u>Times**</u>
Highland Avenue	Both	From Spring to Eastern Terminus	All

** Permits shall be required at all times for all streets listed in this Schedule unless otherwise specified.

[All other provisions remain unchanged]

SECTION TWO: Any ordinances or portions thereof which are inconsistent with the provisions of this Ordinance are hereby repealed as of the effective date of this Ordinance.

SECTION THREE: If any provision of this Ordinance or the application of such provision to any person or circumstance is declared invalid, such invalidity shall not affect the other provisions or applications of this Ordinance which can be given effect, and to this end, the provisions of this Ordinance are declared to be severable.

SECTION FOUR: This Ordinance shall take effect immediately upon its passage and adoption according to law.
