**ORDINANCE AMENDING CHAPTER 680: “VEHICLES AND TRAFFIC” TO CREATE A
DROP OFF ZONE ON OAKLAND STREET NEAR MAPLE AVENUE TO ENSURE SAFE
STUDENT DROP-OFF AND PICK-UP AT RED BANK BOROUGH PRESCHOOL FACILITIES**

BE IT ORDAINED by the Mayor and Council of the Borough of Red Bank, County of Monmouth, State of New Jersey, that Section 680-56 – Schedule XXII: “Dropoff Zones” within Article V: “Schedules” of Chapter 680: “Vehicles and Traffic” of the Borough’s Revised General Ordinances is hereby amended as follows (~~stricken~~ text deleted; underlined text added):

§ 680-56 Schedule XXII. Dropoff Zones.

In accordance with the provisions of § 680-7B of this chapter, the following described locations are hereby designated as drop-off zones:

Name of Street	Side	Location	Times
Drs. James Parker Boulevard	South	Starting at a point 80 feet west of Park Street and extending 70 feet in a westerly direction	Between the hours of 7:00 a.m. and 10:00 a.m. and between 3:00 p.m. and 6:00 p.m., Monday through Friday
East Sunset Avenue	North	Starting at a point 25 feet west of South Bridge Avenue and extending 60 feet in a westerly direction	
<u>Oakland Street</u>	<u>South</u>	<u>Starting at a point 150 feet west of Maple Avenue and extending 40 feet in a westerly direction</u>	<u>Between the hours of 8:30 a.m. and 9:30 a.m. and between the hours of 2:30 p.m. and 3:30 p.m.</u>

BE IT FURTHER ORDAINED by the Mayor and Council of the Borough of Red Bank that any ordinances or portions thereof which are inconsistent with the provisions of this Ordinance are hereby repealed as of the effective date of this Ordinance. All other provisions of the Revised General Ordinances are ratified and remain in full force and effect.
