BOROUGH OF RENOVO CLINTON COUNTY, PENNSYLVANIA RESOLUTION 6-2024

A RESOLUTION OF THE COUNCIL OF THE BOROUGH OF RENOVO, CLINTON COUNTY, PENNSYLVANIA, TO APPOINT MEMBERS & ALTERNATE MEMBERS OF THE QUALITY OF LIFE HEARING BOARD

WHEREAS, on January 17, 2018, Renovo Borough Council enacted a Quality of Life Ordinance, Ordinance No. 798;

WHEREAS, the Quality of Life Ordinance permits persons receiving a violation ticket to request a hearing before a Quality of Life Hearing Board which shall consist of three (3) residents from the Borough, appointed by the Borough Council; and

WHEREAS, the Ordinance further authorizes Council to appoint two (2) alternates to serve if the regular Quality of Life Hearing Board members are unavailable.

THEREFORE, BE IT RESOLVED as follows:

- 1. Members of the Quality of Life Hearing Board shall serve three-year terms and shall be so fixed that the term of office of one member shall expire each year. The two (2) alternates shall likewise serve three-year terms, which can coincide with the term of a regular member but the terms of the alternates shall not expire the same year.
- 2. Members of the Quality of Life Hearing Board in the Borough shall not be a member of Council or an employee of the Borough.

- 3. Kevin Dwyer is appointed a member of the Board to serve until the first regular meeting of Renovo Borough Council in 2027.
- 4. Shannon Bruno is appointed a member of the Board to serve until the first regular meeting of Renovo Borough Council in 2025.
- 5. Paul Balchun is appointed a member of the Board to serve until the first regular meeting of Renovo Borough Council in 2026.
- 6. Gregory Scere is appointed to serve as an alternate of the Board until the first regular meeting of Renovo Borough Council in 2026.
- 7. Mitch Gavlock is appointed to serve as an alternate of the Board until the first regular meeting or Renovo Borough Council in 2025.
- 8. Any member of the Quality of Life Hearing Board may be removed for malfeasance, misfeasance, or nonfeasance in office or for other just cause by a majority of the Renovo Borough Council taken after the member has received fifteen (15) days' advanced notice of the intent to take such a vote. A hearing shall be held in connection with the vote if the member shall request it in writing.
- 9. The Quality of Life Hearing Board shall elect from its membership it's officers who shall serve annual terms as shall and may succeed themselves. For the conduct of any hearing and the taking of an action, a quorum shall not be less than a majority of all of the members of the Board. In the absence or unavailability of a member, an alternate member shall take the place of such absent member for the meeting.
