BOROUGH OF RENOVO, CLINTON COUNTY, PENNSYLVANIA  
ORDINANCE NO. 816 OF 2024

An ordinance of the Borough of Renovo, County of Clinton, Commonwealth of Pennsylvania, amending Section 15-307 and Section 15-308 of the Borough Code to change parking time limits and specific locations on certain days and hours and to set forth the penalties for violations.

WHEREAS, to establish uniformity concerning limited time parking spaces and for the best interests of residents and visitors of Renovo Borough, Renovo Borough Council wishes to amend sections 15-307 and 15-308 of the Borough Code and set forth the locations, times and dates of limited time parking spaces and set penalties for parking violations;

NOW, THEREFORE BE IT ENACTED AND ORDAINED, and it is HEREBY ENACTED AND ORDAINED by the authority of the Borough of Renovo as follows:

Section 307 of Chapter 15 (Section 15-307) of the Renovo Borough Code is hereby repealed.

Section 15-307 shall now read:

No person shall park a vehicle, or allow the same to remain parked for longer than the time herein indicated, in any of the following locations, at any time on the days and hours herein indicated:

Highway	Side	Location	Days and Hours	Parking Time Limit
Huron Avenue	North	Between 15 Minute Parking Sign and No Parking sign in front of post office	Monday - Saturday 8 AM - 5 PM	15 minutes
Erie Avenue	South	Between 4 <sup>th</sup> Street and the entrance to the bank parking lot	Monday - Friday 9 AM - 5 PM	15 minutes
Erie Avenue	South	The first marked Parking spot east of 7 <sup>th</sup> Street	Everyday 8 AM - 8 PM	15 minutes

Seventh Street	East	The first marked parking spot south of Erie Avenue	Everyday 8 AM - 8 PM	15 minutes
Twelfth Street	West	The marked parking spot in front of 148 Twelfth Street	Monday - Saturday 12 PM - 5 PM	15 minutes

Section 308 of Chapter 15 (Section 15-308) of the Renovo Borough Code is hereby repealed.

Section 15-308 shall now read:

1. Any person who shall violate §15-301, 15-302, 15-303, 15-304, 15-305 or 15-307 herein shall, upon conviction be sentenced to pay a fine of not less than \$25, and not more than \$50 and costs of prosecution, and, in default of payment of such fine and costs, to imprisonment for not more than 30 days.

2. Whenever any vehicle is in violation of any provision of §15-301 through §15-307, or any provision of Sections §3353 or §3354 of Title 75 (75 Pa. C.S. §3353 or §3354), a police officer or other authorized person shall attach to or place upon a vehicle a notice (commonly referred to as a "parking ticket") stating that the vehicle was parked in violation of §15-301 through §15-307 or §3353 or §3354 of Title 75. A parking ticket may be served personally upon the operator of a vehicle who is present or nearby at the time of service or by placing the ticket on the vehicle.

- a. The notice shall state the section violated, the license number of the vehicle involved in the violation, the location where the violation took place, the date and time, and any other facts that might be necessary in order to secure a clear understanding of the circumstances attending the violation. The notice shall also state the amount of the fine up to the maximum with instructions to the owner or driver of the vehicle that if they pay the fine to the Renovo Borough, in person or by mail, within 72 hours after the time of the notice, that it will save the violator from prosecution and from payment of additional costs.
- b. The fine indicated shall be no greater than what is outlined in this part, or in Title 75 Sections §3353 or §3354.

3. If a person does not respond to the parking violation notice within the specified 72 hours, a police officer may file a citation within 30 days of the violation with the proper issuing authority as described in Rule 401 of the PA Rules of Criminal Procedure. The fine shall not exceed the fine that is authorized by ordinance or by applicable statute.

- a. Nothing in this section shall preclude a police officer or authorized person from

notifying the owner or driver of a parking violation notice, orally or in writing, that the violation is outstanding beyond 72 hours prior to filing a citation with the issuing authority.

Repealer:

All ordinances or parts of ordinances conflicting with any provision of this Ordinance are hereby repealed insofar as the same affects this Ordinance.


Effective Date:
