

**VILLAGE OF RIDGEWOOD
ORDINANCE NO. 4103**

AN ORDINANCE TO AMEND CHAPTER 145, FEES, OF THE CODE OF THE VILLAGE OF RIDGEWOOD, AT SECTION 145-4, DEPARTMENTAL FEES, AND AT SECTION 145-6, ENUMERATION OF FEES RELATING TO CODE CHAPTERS, AMENDING FEES FOR THE DEPARTMENT OF RECREATION, PARKS AND SHADE TREE DIVISIONS, FOR ADOPT A TREE AND DONATIONS OF MEMORIAL TREES AND BENCHES

BE IT ORDAINED by the Village Council of the Village of Ridgewood:

Section 1. Chapter 145, Fees, at Section 145-4, Departmental Fees, and at Section 145-6, Enumeration of Fees Relating to Code Chapters, of The Code of the Village of Ridgewood, is hereby amended as follows:

Village "Adopt a Tree"

\$1,000 per tree
Special select species may cost extra.
Placement restrictions apply.
Includes purchase and installation only.
Maintenance is the responsibility of the homeowner.

Commemorative/Memorial Tree

\$1,500 per tree
Includes tree, installation and plaque.

Commemorative/Memorial Bench

\$5,000 per bench
Includes bench, installation, concrete pad and plaque.

Parks and Shade Tree Divisions

Village shade tree “adopt a tree”	\$450 per tree (Special select species may cost extra. Placement restrictions apply. Includes purchase and installation only. Maintenance is the responsibility of the homeowner.)
Commemorative/memorial tree	\$650 (Includes tree, bronze plate footing/inscription, installation, and continued Village maintenance.)
Commemorative/memorial bench	\$850 (includes bench, cement installation, and plaque.)

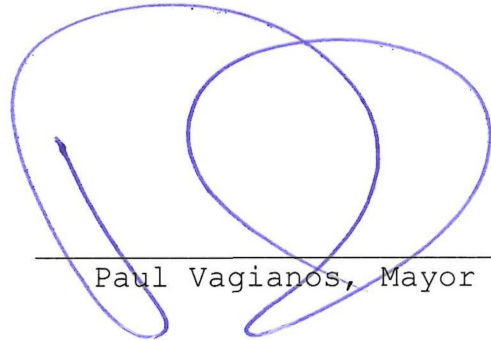
Section 2: Except as herein amended and supplemented, Chapter 145, Fees, of The Code of The Village of Ridgewood remains in full force and effect.
