AN ORDINANCE TO AMEND CHAPTER 145, FEES, OF
THE CODE OF THE VILLAGE OF RIDGEWOOD, AT SECTION 145-6,
“ENUMERATION OF FEES RELATING TO CODE CHAPTERS”

BE IT ORDAINED by the Village Council of the Village of Ridgewood:

Section 1. Chapter 145, Fees, at Section 145-6, Enumeration of Fees Relating to Code Chapters, of The Code of the Village of Ridgewood is hereby amended as follows:

Section 246-4, Permit Fees	Fee
For a ministerial soil-moving permit	\$50
For a minor soil-moving permit	\$150
For a major soil-moving permit	\$200
Plus, per cubic yard	\$0.25

Special meeting requested by interested party	Fee
Engineering review and site inspection for single-family detached homes when a lot's impervious area is increased more than 200 square feet	\$150.00

Chapter 246, Soil Removal

Section 246-4, Permit Fees	Fee
For a ministerial soil-moving permit	\$50
For a minor soil-moving permit	\$125
For a major soil-moving permit	\$150
Plus, per cubic yard	\$0.25

Section 2: Except as herein amended and supplemented, Chapter 145, Fees, of The Code of The Village of Ridgewood remains in full force and effect.

Section 3: This ordinance shall take effect on immediately upon passage and publication as required by law.

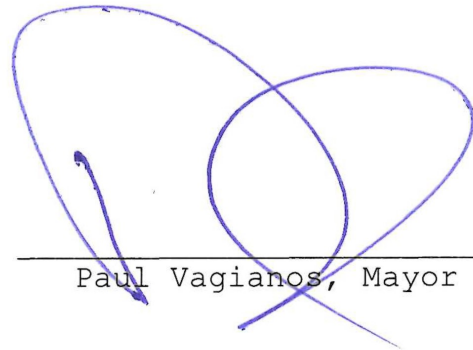

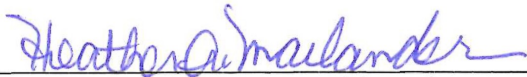
