### BOROUGH OF RIVER EDGE ORDINANCE #24-19

# AN ORDINANCE AMENDING THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF RIVER EDGE, CHAPTER 435, "ADMINISTRATION"

BE IT ORDAINED by the Mayor and Council of the Borough of River Edge, County of Bergen, State of New Jersey, as follows:

<u>Section 1.</u> Section 435-3, entitled "Organization" of Article II, entitled "Board of Health" is hereby amended as follows:

#### Delete:

The Board of Health shall organize annually on the last Monday of January and shall elect a President, Vice President and a Secretary and appoint a Health Officer and Public Health Nurse and such other officers or employees as the Board may deem necessary, all of whom shall hold office for one year unless otherwise specified in the election or the appointment for a designated longer or shorter period.

### Add:

The Board of Health shall organize annually on the first Tuesday of February and shall elect a President, Vice President and a Secretary and appoint a Health Officer and Public Health Nurse and such other officers or employees as the Board may deem necessary, all of whom shall hold office for one year unless otherwise specified in the election or the appointment for a designated longer or shorter period.

<u>Section 2.</u> Section 435-4, entitled "Meetings" of Article II, entitled "Board of Health" is hereby amended as follows:

#### **Delete:**

A. Regular meetings. Regular meetings shall be held on the last Monday of January, March, June, September and November of each year at a time to be determined by the Board annually. If the last Monday of the month shall be a legal holiday, the regular meeting shall be rescheduled.

## Add:

A. Regular meetings. Regular meetings shall be held on the first Tuesday of February, May, September and December of each year at a time to be determined by the Board annually. If the first Tuesday of the month shall be a legal holiday, the regular meeting shall be rescheduled.

<u>Section 3.</u> Any ordinances or parts thereof inconsistent herewith any are hereby repealed to the extent of such inconsistency.

<u>Section 4.</u> In case any clause, sentence, section or other provision of this ordinance, or the application thereof to any person or circumstance, shall be adjudged by a court of competent jurisdiction to be invalid, such judgment shall not affect, impair or repeal the remainder of this ordinance except insofar as the clause, sentence, section or other provision so declared invalid shall be inseparable from the remainder thereof.

<u>Section 5.</u> This Ordinance shall take effect immediately upon final passage and publication as required by law.
