WHEREAS, the Developer posted an 18 month Maintenance and Guarantee Security in the form of cash escrow on said public improvements on terms acceptable to Richland Township, and delivered as-built plans to the Township:

- 1. The Township of Richland does hereby take over and accept the sanitary sewer line located in the Right-of-Way of Cook Road as public sewer, as well as acceptance of an easement on Lot 3 of Fawcett Terrace Plan of Lots, as recorded in Volume 19644, Page 212.
- 2. The acceptance shall include all 8-inch sanitary sewers (approximately 72 linear feet) and 1 manhole constructed within the Right-of-Way.
