

**TOWNSHIP OF ROCKAWAY
COUNTY OF MORRIS, STATE OF NEW JERSEY**

ORDINANCE NO. O-21-26

ORDINANCE PROVIDING FOR THE IMPROVEMENT OF THE WATER SUPPLY AND DISTRIBUTION SYSTEM, THE SANITARY SEWERAGE COLLECTION SYSTEM AND THE STORMWATER MANAGEMENT SYSTEM IN AND BY THE TOWNSHIP OF ROCKAWAY, IN THE COUNTY OF MORRIS, NEW JERSEY, AND APPROPRIATING \$1,354,201.76 THEREFOR CONSTITUTING PROCEEDS OF A GRANT FROM THE AMERICAN RESCUE PLAN ACT OF 2021.

BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF ROCKAWAY, IN THE COUNTY OF MORRIS, NEW JERSEY, AS FOLLOWS:

Section 1. The improvement described in Section 2 of this ordinance is hereby authorized as a general improvement to be made or acquired by The Township of Rockaway, in the County of Morris, New Jersey, and there is hereby appropriated therefor the sum of \$1,354,201.76, from the proceeds of a grant received or expected to be received by the Township from the American Rescue Plan Act of 2021 (with a pass through from the State of New Jersey).

Section 2. The improvement hereby authorized and the purpose for the financing of which the appropriation is made as provided in Section 1 of this ordinance is the improvement of the water supply and distribution system, the sanitary sewerage collection system and the stormwater management system in and by the Township, including all infrastructure improvements necessary therefor or incidental thereto, together with all structures, equipment, site work, studies, plans, work, materials and other expenses necessary therefor or incidental thereto, all as shown on and in accordance with the plans therefor on file or to be filed in the office of the Township Clerk and hereby approved.

Section 3. The capital budget or temporary capital budget of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith and the resolutions promulgated by the Local Finance Board showing all detail of the amended capital budget or temporary capital budget and capital program as approved by the Director, Division of Local Government Services, are on file with the Township Clerk and are available for public inspection.


Section 4. This ordinance shall take effect after publication after final passage as provided by law.
