ORDINANCE NO. 0-21-27

AMENDING CHAPTER VII TRAFFIC, ARTICLE I, SECTION 7-10 STOP INTERSECTION, SECTION 7-11 YIELD INTERSECTION AND SECTION 7-12 TURN PROHIBITIONS OF THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF ROCKAWAY, COUNTY OF MORRIS, STATE OF NEW JERSEY

WHEREAS, pursuant to N.J.S.A. 40:48-2, the governing body of a municipality may make, amend, repeal, and enforce such other ordinances, regulations, rules and by-laws not contrary to the laws of this state or of the United States, as it may deem necessary and proper for the good government, order and protection of person and property, and for the preservation of the public health, safety and welfare of the municipality and its inhabitants, and as may be necessary to carry into effect the powers and duties conferred and imposed by this subtitle, or by any law; and

WHEREAS, the Township of Rockaway desires to amend Section 7-6.9 "Parking Prohibited at All Times on Certain Streets", and

WHEREAS, the Township of Rockaway desires to amend Section 7-10 "Stop Intersection", and

WHEREAS, the Township of Rockaway desires to amend Section 7-11 "Yield Intersection", and

WHEREAS, the Township of Rockaway desires to amend Section 7-12 "Turn Prohibitions", and

WHEREAS, pursuant to N.J.S.A. 39:4-8b and N.J.S.A. 39:4-197, the Township may control traffic flow and restrict parking on any street under municipal jurisdiction without the approval of the Commissioner of Transportation.

NOW, THEREFORE, BE IT ORDAINED by the Township Council of the Township of Rockaway, County of Morris, State of New Jersey as follows:

SECTION 1. Section 7-6.9 Parking Prohibited at All Times on Certain Streets is hereby amended to include the following;

SECTION 6. If any section, subsection, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid by any Court of competent jurisdiction, such decision shall not affect the remaining portion of this Ordinance.

SECTION 7. This Ordinance shall take effect upon final passage and approval in accordance with law.
