**ORDINANCE NO. O-21-29**

**ORDINANCE PROVIDING FOR THE UNDERTAKING OF THE FORD-FAESCH HOUSE CONSTRUCTION DOCUMENTS PROJECT BY THE TOWNSHIP OF ROCKAWAY, IN THE COUNTY OF MORRIS, NEW JERSEY, AND APPROPRIATING \$15,720 THEREFOR CONSTITUTING PROCEEDS OF A GRANT FROM THE MORRIS COUNTY HISTORIC PRESERVATION TRUST.**

**BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF ROCKAWAY, IN THE COUNTY OF MORRIS, NEW JERSEY, AS FOLLOWS:**

Section 1. The improvement described in Section 2 of this ordinance is hereby authorized as a general improvement to be made or acquired by The Township of Rockaway, in the County of Morris, New Jersey, and there is hereby appropriated therefor the sum of \$15,720, from the proceeds of a grant received or expected to be received by the Township from the Morris County Historic Preservation Trust.

Section 2. The improvement hereby authorized and the purpose for the financing of which the appropriation is made as provided in Section 1 of this ordinance is the undertaking of the Ford-Faesch House Construction Documents Project by the Township which project relates to exterior and interior restoration of the Ford-Faesch House including the flooring, walls and ceiling finishes and replacement of the roof thereon, together with all work, materials and other expenses necessary therefor or incidental thereto, all as shown on and in accordance with the plans therefor on file or to be filed in the office of the Township Clerk and hereby approved.

Section 3. The capital budget or temporary capital budget of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith and the resolutions promulgated by the Local Finance Board showing all detail of the amended capital budget or temporary capital budget and capital program as approved by the Director, Division of Local Government Services, are on file with the Township Clerk and are available for public inspection.

Section 4. This ordinance shall take effect after publication after final passage as provided by law.
