## ORDINANCE NO. 0-22-18

## ORDINANCE REPEALING PRIOR ORDINANCES CONCERNING BOWLBYVILLE SEWER PROJECT OF THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF ROCKAWAY, COUNTY OF MORRIS, STATE OF NEW JERSEY

**WHEREAS**, on July 12, 2022 the Council passed Resolution R-22-122 memorializing its unanimous decision to impose no assessments on the owners of any property served by the Bowlbyville Sewer Line; and

**WHEREAS**, the decision unanimously made by the Council makes it appropriate and necessary to repeal certain prior ordinances concerning the Bowlbyville sewer project and/or assessments related thereto; and

**WHEREAS**, the Council deems it appropriate and in the interests of the Township and its citizens to take such action and, specifically, to repeal Ordinances 93-5 and 04-26;

**NOW, THEREFORE, BE IT ORDAINED** by the Township Council of the Township of Rockaway, County of Morris, State of New Jersey, as follows:

- I Ordinances 93-5 and 04-26 are hereby repealed.
- II All Ordinances, Resolutions, Regulations or parts of Ordinances, Resolutions and Regulations inconsistent herewith are hereby repealed to the extent of such inconsistency.
- III If any section, article, subdivision, clause or provision of this Ordinance shall be judged invalid such adjudication shall apply only to the section, paragraph, article, subdivision, clause or provision so adjudged, and the remainder of this Ordinance shall be deemed and effective.
- IV This Ordinance shall take effect upon final passage and approval in accordance with law.
