**AMENDMENT TO THE SALARY ORDINANCE
ORDINANCE NO. 2020-4**

AN ORDINANCE TO AMEND AN ORDINANCE ENTITLED "AN ORDINANCE TO FIX THE SALARY, WAGE OR COMPENSATION OF PERSONS HOLDING OFFICE, POSITION OR EMPLOYMENT IN THE BOROUGH OF ROCKLEIGH, COUNTY OF BERGEN, STATE OF NEW JERSEY"

BE IT RESOLVED by the Mayor and Council of the Borough of Rockleigh as follows:
