ORDINANCE NO. 2767

AN ORDINANCE AMENDING CHAPTER 7 OF THE CODE OF THE BOROUGH OF ROSELLE PARK ENTITLED, “TRAFFIC,” REPEALING SECTION 44 ENTITLED, “BUSINESS-ONLY PARKING”

BE IT ORDAINED by the Mayor and Council of the Borough of Roselle Park, County of Union, State of New Jersey that Chapter 7 of the Code of the Borough of Roselle Park be and hereby is amended as follows:

SECTION 1. Abolition of Business Only Parking Provisions

§ 7-44 ~~BUSINESS ONLY PARKING. (RESERVED)~~

~~§ 7-44.1 Spaces Designated.~~

~~The seven municipal parking spaces located in front of La Catena shall be designated as business only parking between the hours of 10:00 a.m. and 10:00 p.m. everyday.~~

~~§ 7-44.2 Enforcement.~~

~~The Roselle Park Police Department shall be empowered to enforce this section consistent with the towaway and penalty provisions and discretions set forth in § 7-3, Tow-Away, and § 7-4, Penalties, of the Code of the Borough of Roselle Park.~~

~~§ 7-44.3 Enforcement.~~

~~La Catena shall pay the Borough of Roselle Park an administrative fee of \$100 per year, per parking space, for each year that La Catena remains in business, and this section remains in effect. Such payment shall be made in full no later than January 31 of each calendar year. Full payment for calendar year 2021 shall be made to the Borough by La Catena no later than 30 calendar days after the effective date of the foregoing Ordinance.~~

SECTION 2. Invalidity

If any section or portion of a section of this Code shall be invalid for any reason, such invalidity shall not affect the validity of the remaining sections or portions of this Ordinance.

SECTION 3. Inconsistent Ordinances Repealed.

All Ordinances or parts of Ordinances, to the extent that they are inconsistent herewith, are hereby repealed.

SECTION 4. Captions.

Captions contained in this Ordinance have been included only for the purpose of facilitating reference to the various sections and are not intended and shall not be utilized to construe the intent and meaning of the text of any section. Likewise, all strike through text, ~~thusly~~, should be considered a deletion from Borough Code, and all bolded text, **thusly**, should be considered an addition to Borough Code.

SECTION 5. Effective Date.

This Ordinance shall become effective upon publication of the Notice of Final Adoption prepared by the Office of the Borough Clerk.
