ORDINANCE NUMBER 2739-24

AN ORDINANCE TO AMEND AND SUPPLEMENT PART IV "GENERAL ORDINANCES," CHAPTER 190 "ENTERTAINMENT LICENSE" OF THE CODE OF THE BOROUGH OF ROSELLE

WHEREAS, the Borough of Roselle (hereinafter "the Borough") requires business owners to obtain an entertainment license as an official permit to conduct specified activities throughout the Borough; and

WHEREAS, the Borough deems it necessary to amend and supplement the Code of the Borough to clarify the period length of the entertainment license to make clear that the entertainment license must be renewed annually.

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Council of the Borough of Roselle, that the Code of the Borough of Roselle, Part IV, Chapter 190 "Entertainment License," is hereby amended as follows (additions in **bold**, deletions removed).

Chapter 190:

<u>§190-8</u>.

The fee for the entertainment license is \$300 per year. This license must be renewed annually. Any licenses issued will expire one calendar year from the date of issuance.
