ORDINANCE NUMBER 2816-26

**AN ORDINANCE AMENDING CHAPTER 523 “VEHICLES AND TRAFFIC”
SECTION 138 “SCHEDULE XXIX: RESTRICTED HANDICAP PARKING SPACES”**

WHEREAS, the Borough Council of the Borough of Roselle previously adopted Ordinance 2724-23 on December 20, 2023, which among other things, added renewal requirements for restricted handicap parking spaces reserved for a specific people in front of certain residences; and

WHEREAS, the Roselle Police Department has processed handicap parking space renewal applications and independently verified numerous deceased residents who are still listed in Schedule XXIX; and

WHEREAS, the Borough Council finds it is in the best interest of the residents of the Borough of Roselle to update Schedule XXIX accordingly to remove those who failed to submit renewal applications or were otherwise verified to have moved or be deceased.

NOW THEREFORE, BE IT ORDAINED, by the Borough Council of the Borough of Roselle that:

SECTION I. Amendments to Schedule XXIX: Restricted Handicap Parking Spaces
Chapter 523 “Vehicles and Traffic,” Section 138 “Schedule XXIX: Restricted Handicap Parking Spaces” of the Code of the Borough of Roselle is hereby amended as follows (additions in **bold**, deletions ~~struck through~~):

§523-138 Schedule XXIX: Restricted Handicap Parking Spaces.

B. Pursuant to §523-38B, restricted handicap parking spaces reserved for a specific person in front of a certain residence are hereby established as described below:

SECTION II. Upon adoption, the Borough Clerk shall forward a copy of this ordinance to the Superintendent of the Department of Public Works who shall ensure that all signs related to restricted handicap parking spaces eliminated as part of this ordinance are removed in a timely fashion.

SECTION III. If any section, subsection, provision, clause, or portion of this ordinance is adjudged unconstitutional or invalid by a court of competent jurisdiction, such adjudication shall not affect the remaining sections, subsections, provisions, clauses, or portions, which shall be deemed severable therefrom.

SECTION IV. All ordinances or parts of ordinances inconsistent with or in conflict with this Ordinance are hereby replaced and/or repealed to the extent of such inconsistency.

SECTION V. This Ordinance shall take effect at the time and in the manner provided by law.
