Section 1. Legislative Intent:

1.1 It is the intent of this Local Law to allow Trustees of the Village of Rouses Point to become part-time employees of the Village of Rouses Point.

Section 2. Purpose:

2.1. Due to emergency and exigent circumstances that exist from time to time in the Village of Rouses Point and in light of the experience and expertise that certain Village Board of Trustees possess which would allow Village of Rouses Point Trustees to provide certain services to the Village residents which if not permitted could jeopardize the health, safety, and welfare of the residents of the Village of Rouses Point. That this Local Law shall allow certain Village of Rouses Point Board of Trustees to become part-time employees for the Village for said purposes.

Section 3. **Incompatibility:**

3.1. Despite the existence of potential incompatibility of the Office of a Village of Rouses Point Trustee and that of a Village Employee, the Village Board concludes that it is in the best interests of the Village of Rouses Point to allow certain Village Board of Trustees to become part-time employees of the Village of Rouses Point.

Section 4. **Authority:**

4.1. Section 10 of the Municipal Home Rule Law of the State of New York and Section 4-412 of the Village Law of the State of New York empowers the Village Board of the Village of Rouses Point to protect the health, safety, and welfare of the Village of Rouses Point.

Section 5. Severability:

5.1. If any clause, sentence or paragraph, subdivision, or part of this local law or the application thereof to any person, firm or corporation, or circumstance, shall by adjusted by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgement shall not affect, impair, or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision or part of this local law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

Section 6. Effective Date:

6.1. This local law shall take effect upon the filing with the Secretary of State.
