

#### § 19-4. Holidays

#### Section 1. Legislative Intent:

1.1 It is the intent of this Local Law to amend Chapter 19 "Personnel Policies" and in particular Section 19-4 A "Holidays" of the Village Code of the Village of Rouses Point.

#### Section 2. Purpose:

2.1. Section 19-4 A "Holidays" shall be amended as follows:

#### (Added 1-18-2005 by L.L No. 1-2005).

"New Year's Day, Martin Luther King, Jr. Day, President's Day, Good Friday, Memorial Day, Juneteenth (June 19), July 4th, Labor Day, Columbus Day, Veterans Day, Thanksgiving, Friday after Thanksgiving, December 24 (day before Christmas) Christmas Day."

## Section 3. Authority: Authority

3.1. Pursuant to the ( ) and provisions of Section 10 of the Municipal Home Rule Law of the State of New York and the statutory powers vested in the Board of Trustees of the Village of Rouses Point.

#### Section 4. Severability:

4.1. If any clause, sentence or paragraph, subdivision, or part of this local law or the application thereof to any person, firm or corporation, or circumstance, shall by adjusted by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgement shall not affect, impair, or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision or part of this local law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

#### Section 5. Effective Date:

5.1. This local law shall take effect upon the filing with the Secretary of State.
