

AN ORDINANCE TO AMEND THE CITY OF ROSEVILLE CODE OF ORDINANCES, CHAPTER 133, § 133-16 – WATER AND SEWER DEPARTMENT FEES, TO PROVIDE FOR SANITARY SEWER CLEAN-OUT AND INSPECTION FEES, TO PROVIDE FOR REPEALER, SEVERABILITY, AND EFFECTIVE DATE.

ORDINANCE NO. 1337

TO ADOPT AND PUBLISH AN ORDINANCE AMENDING THE CITY OF ROSEVILLE CODE OF ORDINANCES, CHAPTER 133, § 133-16 – WATER AND SEWER DEPARTMENT FEES, TO PROVIDE FOR SANITARY SEWER CLEAN-OUT AND INSPECTION FEES, TO PROVIDE FOR REPEALER, SEVERABILITY, AND EFFECTIVE DATE.

THE CITY OF ROSEVILLE ORDAINS:

Section 1. Preamble. Whereas, in order to protect and promote public health, safety and welfare and to advance the legitimate and rational regulation of sewage disposal, and to protect the public sanitary sewage system in order to avoid the introduction of grease and other objectionable materials which may reduce the efficiency and/or cause blockages within the system and to provide for the wellbeing and safety of surrounding uses and the public at large, the following ordinance is adopted.

Section 2. The City of Roseville Code of Ordinances, Chapter 133, § 133-16 – Water and Sewer Department Fees, is hereby amended by adding § 133-16(J) to provide as follows:

J. Sanitary Sewer Clean-Out and Inspection Fees. All facilities furnishing food services, including by illustration but not limitation, restaurants, clubs, senior facilities, schools and other businesses furnishing for consumption to the public cooked food products within the City of Roseville shall pay an annual sanitary clean-out and inspection fee of \$300.00 due and payable at the rate of \$75.00 per quarter which shall be added to and included as part of Sanitary Sewer and Water Service charges on the quarterly Water and Sewer bill.

In addition, if more than one annual sewer clean-out is required as determined by the Department of Public Services, the owner of the property and occupant shall jointly and severally be liable for a sanitary sewer clean-out fee of \$300.00 for the next clean-out and \$400.00 for any clean-out thereafter.

If more than an annual inspection of the system is required, the owner and the occupant shall jointly and severally be liable for the payment of an additional inspection fee in the amount of \$150.00 for the next inspection and \$175.00 for any inspections thereafter. Charges for such additional clean-out inspections and associated work shall be included as part of the Water and Sewer charges.

The City of Roseville further reserves the right to pursue the collection of any and all such fees due and owing in any other manner as permitted or provided by law. Upon the completion of any such clean-out or inspection, fees and charges shall be

added to the next quarterly bill. The clean-out involves the portion of the sanitary sewer under public ownership at a location *in* the vicinity of where the facility's sewer line connects to the public system.

Section 3. Repealer. All ordinances or parts of ordinances in conflict herewith are repealed only to the extent necessary to give this ordinance full force and effect.

Section 4. Severability. If any article, section, subsection, sentence, clause, phrase, or portion of this ordinance is held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of remaining portions of the ordinance, being the intent of the City that this ordinance shall be fully severable.

Section 5. Effective Date. This ordinance shall be deemed an emergency ordinance and become immediately effective.
