

AN ORDINANCE TO AMEND THE CITY OF ROSEVILLE CODE OF ORDINANCES, CHAPTER 256, ARTICLE I - PUBLIC SEWERS - § 256-7, TO PROTECT THE PUBLIC SANITARY SEWER SYSTEM IN ORDER TO AVOID THE INTRODUCTION OF GREASE AND OTHER OBJECTIONABLE MATERIALS, TO PROVIDE FOR REPEALER, SEVERABILITY, AND EFFECTIVE DATE.

ORDINANCE NO. 1338

TO ADOPT AND PUBLISH AN ORDINANCE AMENDING THE CITY OF ROSEVILLE CODE OF ORDINANCES, CHAPTER 256, ARTICLE I - PUBLIC SEWERS - § 256-7, TO PROTECT THE PUBLIC SANITARY SEWER SYSTEM IN ORDER TO AVOID THE INTRODUCTION OF GREASE AND OTHER OBJECTIONABLE MATERIALS, TO PROVIDE FOR REPEALER, SEVERABILITY, AND EFFECTIVE DATE.

THE CITY OF ROSEVILLE ORDAINS:

Section 1. Preamble. Whereas, in order to protect and promote public health, safety and welfare and to advance the legitimate and rational regulation of sewage disposal, and to protect the public sanitary sewage system in order to avoid the introduction of grease and other objectionable materials which may reduce the efficiency and/or cause blockages within the system and to provide for the wellbeing and safety of surrounding uses and the public at large, the following ordinance is adopted.

Section 2. The City of Roseville Code of Ordinances, Chapter 256, Article I – Public Sewers, § 256-7 Use of Public Sewers, is hereby amended to add § 256-7 (L) which shall provide as follows:

- L.** All facilities furnishing food services, including by illustration but not limitation, restaurants, clubs, senior facilities, schools and other businesses furnishing for consumption to the public cooked food products within the City of Roseville shall comply with this ordinance as follows:
- (1)** Any such facility constructed following the adoption of this ordinance shall install an adequately sized grease trap.
 - (2)** Any existing facility remodeling to accommodate an expansion of the facility or upgrade as defined in the Michigan Plumbing Code shall timely install a grease trap in order to maintain an occupancy permit.
 - (3)** Any facility which undergoes a change of use or increases the occupancy capacity of the facility shall install a grease trap.
 - (4)** Facilities which demonstrate within a calendar year difficulty in achieving compliance such that two or more sanitary sewer cleanout and/or inspections are required which presently does not have a grease trap, shall timely install a grease trap in order to maintain an occupancy permit.

- (5) Where a grease trap is required, such grease trap shall be adequately sized in accordance with the current United States Environmental Protection Authority Design Manual and any current applicable City standards including any adopted codes or rules issued by the Department of Public Service.
- (6) As a cumulative remedy, costs, including attorney fees for compliance shall be imposed and revocation of an occupancy permit must occur.

Section 3. Repealer. All ordinances or parts of ordinances in conflict herewith are repealed only to the extent necessary to give this ordinance full force and effect.

Section 4. Severability. If any article, section, subsection, sentence, clause, phrase, or portion of this ordinance is held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of remaining portions of the ordinance, being the intent of the City that this ordinance shall be fully severable.

Section 5. Effective Date. This ordinance shall be deemed an emergency ordinance and become immediately effective.
