LOCAL LAW NO. 6 OF 2024 COUNTY OF ROCKLAND STATE OF NEW YORK

(Sponsors: Hon. Alden H. Wolfe, Hon. Douglas J. Jobson)

A local law in the County of Rockland amending Local Law No. 5 of 2023, to correct a typographical errors and extend the effective start date.

Be it enacted by the Legislature of the County of Rockland as follows:

Section 1. Amendments of Local Law No. 5 of 2023

This local law will correct a typographical errors and extend the effective date, originally from 270 days after it was filed in the Office of the NYS Secretary of State, (creating an effective date of July 6, 2024), and amending the effective date to October 1, 2024.

Section 2. Amendments to correct typographical errors

A. This law amends a portion of Local Law No. 5 of 2023, codified as the Law of Rockland County, Chapter 375, Vehicles and Traffic, § 375-34(C), *Minimum Requirements for an application for a Rockland County livery driver's license*:

§ 375-34 Minimum requirements for an application for a Rockland County livery driver's license

- C. Upon receiving a complete application, the Board must:
 - 1. forward the fingerprints and processing fee to the New York State Division of Criminal Justice Services for review in accordance with <u>NYS VTL Section 498(4)(a)</u> GML § 289.
 - 2. The Board shall review the records received from the New York State Division of Criminal Justice consistent with Article 23-A of the New York State Correction Law and shall consider such records in making a determination to issue the license.
- B. This law amends a portion of Local Law No. 5 of 2023, codified as the Law of Rockland County, Chapter 375, Vehicles and Traffic, § 375-31 *Definitions*:

§375-11 Definitions

TAXI (also, "for-hire vehicle")

A vehicle being used on a for-fire <u>hire</u> basis that picks up passengers without the need for prearrangement of transportation, for example picking up passengers hailing a ride on an *ad hoc* basis; or a motor vehicle registered with the New York State Department of Motor Vehicles as a 'Taxi', bearing a 'Taxi' license plate, and which carries passengers picked up on an *ad hoc* as opposed to pre-arranged basis, which passengers will be charged for such transportation.

Section 3. Amendment to Section 6 of Local Law 5 of 2023

This local law shall take effect on 270 days after it is filed in the office of the NYS Secretary of State October 1, 2024.
